12	(G) include evacuation plans for air and
13	water assets that do not impinge on the safety
14	of human life;
15	(H) are able to be completely executed
16	within 15 minutes of detection of a seismic
17	event or, if not possible within 15 minutes,
18	within a reasonable timeframe;
19	(I) are able to be completely executed by
20	servicemembers on foot from any location with-
21	in the tsunami inundation zone;
22	(J) are exercised biennially by each unit
23	and sector located in a tsunami inundation
24	zone; and

1	(K) are evaluated by leadership at each
2	unit and sector located in a tsunami inundation
3	zone annually.
4	(3) Consultation.—In establishing the evacu-
5	ation plans under paragraph (1), the Commandant
6	shall consult local governments.
7	(b) REPORT.—Not later than 2 years after the date
8	of enactment of this Act, the Commandant shall submit

3	order, including illicit drug and migrant activity;
4	(4) an identification of current technology and
5	assets the Coast Guard has to mitigate the gaps

8	mitigate such gaps, including any capabilities the
9	Coast Guard currently possesses that can be de-
