AN ACT

- 1 Providing a process for the designation of certain species.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Endangered
- 6 Species Coordination Act.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- 11 "Acceptable data." Current, best available scientific and <--
- 12 commercial, empirical data as evidenced in supporting
- 13 documentation, statistics, reports, studies or research. As it

- 1 pertains to wild trout stream designation, such data that is
- 2 replicable and testable. EMPIRICAL, REPLICABLE AND TESTABLE DATA <--
- 3 AS EVIDENCED IN SUPPORTING DOCUMENTATION, STATISTICS, REPORTS,
- 4 STUDIES OR RESEARCH.
- 5 "Action." Any of the following activity:
- 6 (1) Promulgation of regulations.
- 7 (2) Designations or listing of species. <--
- 8 (3) Enforcement of rules and regulations.
- 9 "Acts." Any of the following:
- 10 (1) The Endangered Species Act of 1973, (Public Law 93-
- 11 205, 16 U.S.C. § 1531 et seq.) +.
- 12 (2) The act of June 23, 1982 (P.L.597, No.170), known as

- 13 the Wild Resource Conservation Act.
- 14 (3) 30 Pa.C.S. (relating to fish).
- 15 (4) 34 Pa.C.S. (relating to game).
- 16 "AUTHORIZED PERSON." THE TERM INCLUDES:
- 17 (1) PERSONS, INCLUDING ANY NATURAL PERSON, PARTNERSHIP,
- 18 ASSOCIATION, CORPORATION OR OTHER LEGAL ENTITY, INCLUDING
- 19 ASSOCIATED CONSULTANTS, SCIENTISTS AND PLANNERS, INVOLVED IN
- 20 COMMERCIAL ACTIVITIES INVOLVING POTENTIAL LAND DISTURBANCES
- 21 OR OTHER ACTIVITY FOR WHICH A PERMIT IS REQUIRED BY FEDERAL
- 22 OR STATE LAW AND WHICH MAY IMPACT LISTED SPECIES OR THEIR
- 23 CRITICAL HABITATS, AS DEFINED BY THE ENDANGERED SPECIES ACT
- 24 OF 1973 (PUBLIC LAW 93-205, 16 U.S.C. § 1531 ET SEQ.) OR THIS
- 25 ACT.
- 26 (2) PERSONS WITH A BONA FIDE INTEREST INVOLVED IN
- 27 CONSERVATION PLANNING OR INVOLVED IN RESOURCE MANAGEMENT AS
- 28 DETERMINED BY THE DEPARTMENT OF CONSERVATION AND NATURAL
- 29 RESOURCES.
- 30 "Centralized database." The database of listed species and <--

1 critical habitat maintained in accordance with this act. THE

<--

- 2 DATABASE OF LISTED SPECIES AND CRITICAL HABITAT MAINTAINED IN
- 3 ACCORDANCE WITH THIS ACT AND OTHER DESIGNATED SPECIES OR
- 4 INFORMATION.
- 5 "Commonwealth agency." Any of the following:
- 6 (1) The Department of Conservation and Natural Resources 7 of the Commonwealth.
- 8 (2) The Pennsylvania Fish and Boat Commission.
- 9 (3) The Pennsylvania Game Commission.
- 10 "Critical habitat." The specific areas within the geographic
- 11 area occupied by a listed species designated in accordance with
- 12 the Endangered Species Act of 1973 (Public Law 93-205, 16 U.S.C.
- 13 \$1531 et seq.).
- 14 "Department." The Department of Conservation and Natural
- 15 Resources of the Commonwealth.
- 16 "Listed species." Species of fish, wildlife or plants
- 17 designated under the acts as "endangered," "Pennsylvania
- 18 endangered, " "threatened" or "Pennsylvania threatened" and
- 19 included in the centralized database.
- 20 "Persons." The term includes:
- 21 (1) Persons, including any natural person, partnership,
- 22 association, corporation or other legal entity, including
- 23 associated consultants, scientists and planners, involved in-
- 24 commercial activities involving potential land disturbances
- 25 or other activity for which a permit is required by Federal
- or State law and which may impact listed species or their
- 27 critical habitats, as defined by the Endangered Species Act
- 28 of 1973 (Public Law 93 205, 16 U.S.C. § 1531 et seq.) or this
- 29 act.
- 30 (2) Persons with a bona fide interest involved in

- 1 conservation planning or involved in resource management as
- 2 determined by the Department of Conservation and Natural
- 3 Resources.
- 4 "Wild trout stream." A wilderness trout stream, a Class A
- 5 wild trout stream or any other stream or stream segment
- 6 designated by the Pennsylvania Fish and Boat Commission as a
- 7 wild trout stream.
- 8 Section 3. Coordination of designation.
- 9 No Commonwealth agency may take action to designate or
- 10 consider fish, wildlife or plants as threatened or endangered
- 11 unless the fish, wildlife or plants are designated under the
- 12 Endangered Species Act of 1973 (Public Law 93-205, 16 U.S.C. §
- 13 1531 et seq.) or pursuant to this act.
- 14 Section 4. Designation process.
- 15 (a) Applicable law. -- Any action by a Commonwealth agency to
- 16 designate fish, wildlife or plants as threatened or endangered
- 17 or to designate a stream as a wild trout stream shall be subject
- 18 to the requirements of the act of July 31, 1968 (P.L.769,
- 19 No.240) referred to as the Commonwealth Documents Law, and the
- 20 act of June 25, 1982 (P.L.633, No.181), known as the Regulatory
- 21 Review Act. NOTHING UNDER THIS SUBSECTION SHALL BE CONSTRUED TO <--
- 22 REQUIRE THE PENNSYLVANIA FISH AND BOAT COMMISSION OR THE
- 23 PENNSYLVANIA GAME COMMISSION TO COMPLY WITH THE REGULATORY
- 24 REVIEW ACT WITH RESPECT TO ANY RULES OR REGULATIONS OTHER THAN
- 25 THOSE RELATING TO THREATENED OR ENDANGERED SPECIES OR
- 26 DESIGNATION OF WILD TROUT STREAMS.
- 27 (b) Detailed reasons and summary of data and methodology.--
- 28 The Commonwealth agency shall provide detailed reasons and a
- 29 summary of the acceptable data and methodology upon which the
- 30 proposed designation is based, as well as the activities that

- 1 may be affected by such designation, to the Independent
- 2 Regulatory Review Commission and to the standing committees of
- 3 the Senate and the House of Representatives with jurisdiction
- 4 over the Commonwealth agency for purposes of this act.
- 5 (c) Inclusion in centralized database. -- Upon final
- 6 promulgation of a regulation designating a fish, wildlife or
- 7 plant species as threatened or endangered, that species shall be
- 8 included in the centralized database.
- 9 (d) Removal. -Any species designated as threatened or <--
- 10 endangered pursuant to 30 Pa.C.S. (relating to fish) or 34
- 11 Pa.C.S. (relating to game) prior to the effective date of this
- 12 section shall be removed from the centralized database after a
- 13 period of two years unless the Commonwealth agency redesignates
- 14 the species as threatened or endangered in accordance with the-
- 15 provisions of this act.
- 16 Section 5. Designation determination and data.
- 17 (a) General rule. -- All Commonwealth agency actions to
- 18 designate fish, wildlife or plants as Pennsylvania threatened or
- 19 Pennsylvania endangered species shall be promulgated as
- 20 regulations in accordance with this act, solely on the basis of
- 21 acceptable data.
- 22 (b) Conditions for designation. --
- 23 (1) Any designation of a Pennsylvania endangered species
- 24 shall be made only when the species is in danger of
- 25 extinction throughout all or a significant portion of its
- 26 range WITHIN THIS COMMONWEALTH.
- 27 (2) Any designation of a Pennsylvania threatened species

- shall be made only when the species is likely to become a
- 29 Pennsylvania endangered species throughout all or a
- 30 significant portion of its range within the foreseeable

- 1 future.
- 2 (c) Wild trout streams. -- Any Commonwealth agency action to
- 3 designate a stream or stream segment as a wild trout stream
- 4 shall be promulgated as a regulation based solely on acceptable
- 5 data. The designation of a stream or stream segment as a wild
- 6 trout stream shall not be effective until the regulation is
- 7 promulgated as final.
- 8 Section 6. Permits and approvals.
- 9 When NOTWITHSTANDING ANY OTHER PROVISION OF LAW, IF reviewing <--
- 10 applications for permits, approvals or other authorizations or
- 11 taking actions, OTHER THAN DESIGNATING SPECIES, State and local <--

- 12 government agencies shall consider impacts only to listed
- 13 species and their critical habitats included in the centralized
- 14 database. Permits, approvals, authorizations or regulations
- 15 shall not require persons to conduct field surveys or other-
- 16 activities to determine or evaluate the presence of species or
- 17 their habitats, unless acceptable data exist indicating the
- 18 presence of a listed species in the area. IF FIELD SURVEYS OR <-
- 19 OTHER ACTIVITIES TO DETERMINE OR EVALUATE THE PRESENCE OF LISTED
- 20 SPECIES OR LISTED SPECIES' HABITATS ARE CONDUCTED, THE
- 21 COMMONWEALTH AGENCY WITH JURISDICTIONAL AUTHORITY FOR PROTECTION
- 22 OF THE SPECIES SHALL, WITHIN 30 DAYS OF RECEIVING SURVEY
- 23 RESULTS, PROVIDE EITHER CLEARANCE FOR THE PROJECT, OR DETAILED
- 24 AVOIDANCE MEASURES, DETAILED MINIMIZATION MEASURES OR DETAILED
- 25 MITIGATION MEASURES TO THE APPLICANT. A REQUIREMENT OF AN
- 26 APPLICANT TO PERFORM A SURVEY MUST BE BASED ON ACCEPTABLE DATA
- 27 INDICATING THE LIKELY PRESENCE OF LISTED SPECIES IN THE AREA
- 28 AFFECTED BY THE PROJECT.
- 29 Section 7. Centralized database.
- 30 The department shall develop, maintain and manage the

- 1 operation of the centralized database. Each Commonwealth agency
- 2 shall provide the department with all information identified in
- 3 section 8.
- 4 Section 8. Access to data.
- 5 (a) General rule. -- The department shall provide AUTHORIZED <--
- 6 persons access to data regarding the location of listed species
- 7 or other designated species, including:
- 8 (1) Geographic Information System spatial data
- 9 identifying specific areas in which each listed species or
- other designated species is known to be present.
- 11 (2) Geographic Information System spatial data
- identifying critical habitat areas where listed species occur
- or sensitive habitat of other designated species.
- 14 (3) Geographic Information System spatial data
- identifying buffer areas for listed species or other
- designated species, along with a description of the
- 17 acceptable data, rationale and methodology used by a
- 18 Commonwealth agency to establish the extent of the buffer
- 19 areas.
- 20 (4) The names of all political subdivisions within which
- 21 the listed or other designated species, their habitats and
- 22 buffer areas are located.
- 23 (b) List of potential avoidance and mitigation measures.--
- 24 The department shall also provide AUTHORIZED persons a list of
- 25 potential avoidance and mitigation measures, seasonal
- 26 considerations or other best practices associated with each of
- 27 the listed species or other designated species and habitats.
- 28 (c) Public dissemination. -
- 29 (1) Notwithstanding any provision of law to the
- 30 (C) PUBLIC DISSEMINATION.--NOTWITHSTANDING ANY PROVISION OF <--

- 1 LAW TO THE contrary, the department shall provide the
- 2 information described in subsection (a), including records
- 3 identifying the location of endangered or threatened plant or
- 4 animal species not already known to the general public, to
- 5 AUTHORIZED persons who request it.

6 (2) Persons receiving the information may only disclose <--

<--

- 7 the information to other persons with prior written-
- 8 authorization from the department.
- 9 (d) Use of information.--Information obtained under
- 10 subsection (a) shall be used solely for:
- 11 (1) conservation, development planning, natural
- 12 resources management;
- 13 (2) compliance with statutory and regulatory
- 14 requirements for the protection of listed species applicable
- 15 to permits, approvals or other authorizations; or
- 16 (3) voluntary measures to mitigate impacts to other than
- 17 listed species.
- 18 (e) Civil penalty. Any person intentionally violating the <--
- 19 provisions of subsection (c) or (d) is subject to a civil-
- 20 penalty of not less than \$250 nor more than \$5,000.
- 21 Section 9. Repeal.
- 22 All acts and parts of acts are repealed insofar as they are
- 23 inconsistent with this act.
- 24 (E) CIVIL PENALTY.--THE DEPARTMENT MAY IMPOSE A CIVIL
- 25 PENALTY OF NOT LESS THAN \$1,000 NOR MORE THAN \$10,000 ON ANY
- 26 PERSON WHO INTENTIONALLY VIOLATES THE PROVISIONS OF SUBSECTION
- 27 (C) OR (D).
- 28 SECTION 9. USE OF FUNDS.
- 29 A COMMONWEALTH AGENCY THAT RECEIVES FUNDS UNDER THE PITTMAN-
- 30 ROBERTSON WILDLIFE RESTORATION ACT (50 STAT. 917, 16 U.S.C. 669

- 1 ET SEQ.) OR THE DINGELL-JOHNSON SPORT FISH RESTORATION ACT (64
- 2 STAT. 681, 16 U.S.C. 777 ET SEQ.), IS PROHIBITED FROM
- 3 TRANSFERRING TO ANOTHER STATE AGENCY REVENUES GENERATED THROUGH
- 4 THE SALE OF HUNTING OR FISHING LICENSES FOR THE ADMINISTRATION

- 5 OF THIS ACT.
- 6 Section 10 20. Effective date.

7 This act shall take effect in 90 days.
