## AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- Consolidated Statutes, in firearms and other dangerous articles, further providing for definitions, for licenses,
- for sale or transfer of firearms, for Pennsylvania State
- 5 Police, for firearm sales surcharge, for the Firearm Records
- 6 Check Fund, for licensing of dealers, for administrative
- 7 regulations and for the Firearms Background Check Advisory
- 8 Committee.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:
- 11 Section 1. Section 6102 of Title 18 of the Pennsylvania
- 12 Consolidated Statutes is amended by adding a definition to read:
- 13 § 6102. Definitions.
- 14 Subject to additional definitions contained in subsequent
- 15 provisions of this subchapter which are applicable to specific
- 16 provisions of this subchapter, the following words and phrases,
- 17 when used in this subchapter shall have, unless the context
- 18 clearly indicates otherwise, the meanings given to them in this

- 12 (d) Sheriff to conduct investigation. -- The sheriff to whom
- 13 the application is made shall:

- 15 (5) [conduct a criminal background, juvenile delinquency
- and mental health check following the procedures set forth in
- 17 section 6111 (relating to sale or transfer of firearms),
- 18 receive a unique approval number for that inquiry and record
- the date and number on the application] contact the NICS and

- 23 § 6111. Sale or transfer of firearms.
- 24 [(a) Time and manner of delivery.--
- 25 (1) Except as provided in paragraph (2), no seller shall
- deliver a firearm to the purchaser or transferee thereof
- 27 until 48 hours shall have elapsed from the time of the
- application for the purchase thereof, and, when delivered,
- the firearm shall be securely wrapped and shall be unloaded.
- 30 (2) Thirty days after publication in the Pennsylvania

- 1 Bulletin that the Instantaneous Criminal History Records
- 2 Check System has been established in accordance with the
- Brady Handgun Violence Prevention Act (Public Law 103-159, 18
- 4 U.S.C. § 921 et seq.), no seller shall deliver a firearm to
- 5 the purchaser thereof until the provisions of this section
- 6 have been satisfied, and, when delivered, the firearm shall
- 7 be securely wrapped and shall be unloaded.]
- 8 (b) Duty of seller.--No licensed importer, licensed
- 9 manufacturer or licensed dealer shall sell or deliver any
- 10 firearm to another person, other than a licensed importer,
- 11 licensed manufacturer, licensed dealer or licensed collector,
- 12 [until the conditions of subsection (a) have been satisfied and]
- 13 until he has:
- 14 [(1) For purposes of a firearm as defined in section
- 15 6102 (relating to definitions), obtained a completed
- application/record of sale from the potential buyer or
- 17 transferee to be filled out in triplicate, the original copy
- to be sent to the Pennsylvania State Police, postmarked via
- first class mail, within 14 days of the sale, one copy to be
- 20 retained by the licensed importer, licensed manufacturer or
- 21 licensed dealer for a period of 20 years and one copy to be
- 22 provided to the purchaser or transferee. The form of this
- application/record of sale shall be no more than one page in
- length and shall be promulgated by the Pennsylvania State
- 25 Police and provided by the licensed importer, licensed
- 26 manufacturer or licensed dealer. The application/record of
- sale shall include the name, address, birthdate, gender,
- 28 race, physical description and Social Security number of the
- 29 purchaser or transferee, the date of the application and the
- 30 caliber, length of barrel, make, model and manufacturer's

number of the firearm to be purchased or transferred. The application/record of sale shall also contain the following question:

Are you the actual buyer of the firearm(s), as defined under 18 Pa.C.S. § 6102 (relating to definitions), listed on this application/record of sale? Warning: You are not the actual buyer if you are acquiring the firearm(s) on behalf of another person, unless you are legitimately acquiring the firearm as a gift for any of the following individuals who are legally eligible to own a firearm:

- (1) spouse;
- (2) parent;
- (3) child;
- 14 (4) grandparent; or
- 15 (5) grandchild.

- (1.1) On the date of publication in the Pennsylvania

  Bulletin of a notice by the Pennsylvania State Police that
  the instantaneous records check has been implemented, all of
  the following shall apply:
- 20 In the event of an electronic failure under (i) 21 section 6111.1(b)(2) (relating to Pennsylvania State 22 Police) for purposes of a firearm which exceeds the 23 barrel and related lengths set forth in section 6102, 24 obtained a completed application/record of sale from the 25 potential buyer or transferee to be filled out in 26 triplicate, the original copy to be sent to the 27 Pennsylvania State Police, postmarked via first class 28 mail, within 14 days of sale, one copy to be retained by 29 the licensed importer, licensed manufacturer or licensed 30 dealer for a period of 20 years and one copy to be

1 provided to the purchaser or transferee.

(ii) The form of the application/record of sale shall be no more than one page in length and shall be promulgated by the Pennsylvania State Police and provided by the licensed importer, licensed manufacturer or licensed dealer.

- (iii) For purposes of conducting the criminal history, juvenile delinquency and mental health records background check which shall be completed within ten days of receipt of the information from the dealer, the application/record of sale shall include the name, address, birthdate, gender, race, physical description and Social Security number of the purchaser or transferee and the date of application.
- (iv) No information regarding the type of firearm need be included other than an indication that the firearm exceeds the barrel lengths set forth in section 6102.
- (v) Unless it has been discovered pursuant to a criminal history, juvenile delinquency and mental health records background check that the potential purchaser or transferee is prohibited from possessing a firearm pursuant to section 6105 (relating to persons not to possess, use, manufacture, control, sell or transfer firearms), no information on the application/record of sale provided pursuant to this subsection shall be retained as precluded by section 6111.4 (relating to registration of firearms) by the Pennsylvania State Police either through retention of the application/record of sale or by entering the information onto a computer,

and, further, an application/record of sale received by
the Pennsylvania State Police pursuant to this subsection
shall be destroyed within 72 hours of the completion of
the criminal history, juvenile delinquency and mental

health records background check.

- (1.2) Fees collected under paragraph (3) and section 6111.2 (relating to firearm sales surcharge) shall be transmitted to the Pennsylvania State Police within 14 days of collection.]

- 13 (1.3) In addition to the criminal penalty under section 14 6119 (relating to violation penalty), any person who 15 knowingly and intentionally [maintains or fails to destroy 16 any information submitted to the Pennsylvania State Police 17 for purposes of a background check pursuant to paragraphs 18 (1.1) and (1.4) or] violates section 6111.4 shall be subject 19 to a civil penalty of \$250 per violation. [, entry or failure 20 to destroy.
- 21 (1.4) Following implementation of the instantaneous 22 records check by the Pennsylvania State Police on or before 23 December 1, 1998, no application/record of sale shall be 24 completed for the purchase or transfer of a firearm which 25 exceeds the barrel lengths set forth in section 6102. A 26 statement shall be submitted by the dealer to the 27 Pennsylvania State Police, postmarked via first class mail, 28 within 14 days of the sale, containing the number of firearms 29 sold which exceed the barrel and related lengths set forth in 30 section 6102, the amount of surcharge and other fees remitted

- and a list of the unique approval numbers given pursuant to

  paragraph (4), together with a statement that the background

  checks have been performed on the firearms contained in the

  statement. The form of the statement relating to performance

  of background checks shall be promulgated by the Pennsylvania

  State Police.]
  - (1.5) Contacted the NICS and complied with the requirements of 18 U.S.C. § 922(t) (relating to unlawful acts).
  - (2) Inspected photoidentification of the potential purchaser or transferee, including, but not limited to, a driver's license, official Pennsylvania photoidentification card or official government photoidentification card. In the case of a potential buyer or transferee who is a member of a recognized religious sect or community whose tenets forbid or discourage the taking of photographs of members of that sect or community, a seller shall accept a valid-without-photo driver's license or a combination of documents, as prescribed by the Pennsylvania State Police, containing the applicant's name, address, date of birth and the signature of the applicant.
  - [(3) Requested by means of a telephone call that the Pennsylvania State Police conduct a criminal history, juvenile delinquency history and a mental health record check. The purchaser and the licensed dealer shall provide such information as is necessary to accurately identify the purchaser. The requester shall be charged a fee equivalent to the cost of providing the service but not to exceed \$2 per buyer or transferee.
- 30 (4) Received a unique approval number for that inquiry

- from the Pennsylvania State Police and recorded the date and the number on the application/record of sale form.
  - (5) Issued a receipt containing the information from paragraph (4), including the unique approval number of the purchaser. This receipt shall be prima facie evidence of the purchaser's or transferee's compliance with the provisions of this section.
  - (6) Unless it has been discovered pursuant to a criminal history, juvenile delinquency and mental health records background check that the potential purchaser or transferee is prohibited from possessing a firearm pursuant to section 6105, no information received via telephone following the implementation of the instantaneous background check system from a purchaser or transferee who has received a unique approval number shall be retained by the Pennsylvania State Police.
- 17 For purposes of the enforcement of 18 U.S.C. § (7) 18 922(d)(9), (g)(1) and (s)(1) (relating to unlawful acts), in 19 the event the criminal history or juvenile delinquency 20 background check indicates a conviction for a misdemeanor 21 that the Pennsylvania State Police cannot determine is or is 22 not related to an act of domestic violence, the Pennsylvania 23 State Police shall issue a temporary delay of the approval of 24 the purchase or transfer. During the temporary delay, the 25 Pennsylvania State Police shall conduct a review or 26 investigation of the conviction with courts, local police 27 departments, district attorneys and other law enforcement or 28 related institutions as necessary to determine whether or not 29 the misdemeanor conviction involved an act of domestic 30 violence. The Pennsylvania State Police shall conduct the

- (f) Application of section. --
- 10 (1) For the purposes of this section only, except as
  11 provided by paragraph (2), "firearm" shall mean any weapon
  12 which is designed to or may readily be converted to expel any
  13 projectile by the action of an explosive or the frame or
  14 receiver of any such weapon.
  - (2) The provisions contained in [subsections (a) and] subsection (c) shall only apply to pistols or revolvers with a barrel length of less than 15 inches, any shotgun with a barrel length of less than 18 inches, any rifle with a barrel length of less than 16 inches or any firearm with an overall length of less than 26 inches.
  - (3) The provisions contained in subsection [(a)] (b) (1.5) shall not apply to any law enforcement officer whose current identification as a law enforcement officer shall be construed as a valid license to carry a firearm or any person who possesses a valid license to carry a firearm under section 6109 (relating to licenses).
    - [(4) (i) The provisions of subsection (a) shall not apply to any person who presents to the seller or transferor a written statement issued by the official described in subparagraph (iii) during the ten-day period

ending on the date of the most recent proposal of such
transfer or sale by the transferee or purchaser stating
that the transferee or purchaser requires access to a
firearm because of a threat to the life of the transferee
or purchaser or any member of the household of that
transferee or purchaser.

- (ii) The issuing official shall notify the applicant's local police authority that such a statement has been issued. In counties of the first class the chief of police shall notify the police station or substation closest to the applicant's residence.
- (iii) The statement issued under subparagraph (ii) shall be issued by the district attorney, or his designee, of the county of residence if the transferee or purchaser resides in a municipality where there is no chief of police. Otherwise, the statement shall be issued by the chief of police in the municipality in which the purchaser or transferee resides.]
- (g) Penalties.--
