AN ACT

Amending the act of July 10, 1981 (P.L.214, No.67), entitled "An act relating to the lawful conduct of bingo, prescribing penalties and making a repeal," further providing for 3 DEFINITIONS, FOR rules for licensing and operation and for 4 5 penalties. 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. Section 5(c)(2), (3) and (11) and (d)(5) and (6) <-of the act of July 10, 1981 (P.L.214, No.67), known as the Bingo 10 Law, amended December 15, 1982 (P.L.1299, No.293) and February 11 12, 1988 (P.L.76, No.14), are amended to read: 12 Section 5. - 2 HAVE, UNLESS THE CONTEXT CLEARLY INDICATES OTHERWISE, THE

- 30 "BINGO." A GAME IN WHICH EACH PLAYER HAS A CARD OR BOARD

- 1 CONTAINING FIVE HORIZONTAL ROWS ALL BUT THE CENTRAL ONE
- 2 CONTAINING FIVE FIGURES. THE CENTRAL ROW HAS FOUR FIGURES WITH
- 3 THE WORD "FREE" MARKED IN THE CENTER THEREOF. ANY PREANNOUNCED
- 4 COMBINATION OF SPACES WHEN COMPLETED BY A PLAYER CONSTITUTES
- 5 BINGO. IN THE ABSENCE OF A PREANNOUNCEMENT OF A COMBINATION OF
- 6 SPACES, ANY COMBINATION OF FIVE IN A ROW WHETHER HORIZONTAL OR
- 7 VERTICAL WHEN COMPLETED BY A PLAYER CONSTITUTES BINGO WHEN ITS

- 5 GENERATED THROUGH THE USE OF BALLS OR OTHER OBJECTS SEPARATE
- 6 FROM THOSE TO BE USED ONCE A GAME BEGINS OR THROUGH USE OF A
- 7 WHEEL OR OTHER MECHANICAL DEVICE. PLAYERS MAY PURCHASE CONCEALED
