- 21 (A.1) EXEMPTION. -- FOR THE SOLE PURPOSE OF IMPLEMENTING AND
- 22 ENHANCING A MENTORED HUNTING PROGRAM WITHIN THIS COMMONWEALTH,
- 23 THE COMMISSION [MAY] SHALL ESTABLISH REGULATIONS EXEMPTING
- 24 CERTAIN LIMITED HUNTING ACTIVITIES FROM THE PROHIBITIONS
