## AN ACT

- 1 Providing that any Federal law which attempts to register,
- restrict or ban a firearm or to limit the size of a magazine
- of a firearm in this Commonwealth shall be unenforceable in
- 4 this Commonwealth; and imposing penalties.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Right to Bear
- 9 Arms Protection Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Firearm accessory." An item that is used in conjunction

- 1 with or mounted on a firearm but is not essential to the basic
- 2 function of a firearm.
- 3 Section 3. Federal law relating to firearms, accessories and
- 4 ammunition.
- 5 (a) General rule. -- A Federal law, rule, regulation or order
- 6 created or taking effect after December 31, 2012, shall be
- 7 unenforceable within the borders of this Commonwealth if the
- 8 law, rule, regulation or order attempts to register, restrict or
- 9 ban the ownership or purchase of a firearm, magazine of a
- 10 firearm, firearm accessory or ammunition.
- 11 (b) Penalty. -- An official, agent or employee of the Federal
- 12 Government, Commonwealth or political subdivision who enforces
- 13 or attempts to enforce a Federal law under subsection (a)
- 14 commits a felony of the third degree and, upon conviction, shall
- 15 be subject to imprisonment for not less than one year or more
- 16 than seven years, a fine of not more than \$15,000, or both.
- 17 (c) Enforcement. -- The Attorney General shall prosecute
- 18 violations of this section.
- 19 Section 4. Duty of Attorney General.
- 20 The Attorney General shall defend a resident of this
- 21 Commonwealth who is prosecuted by the Federal Government for a
- 22 violation of Federal law under section 3(a) that attempts to
- 23 register, restrict or ban the ownership or purchase of a
- 24 firearm, magazine of a firearm, firearm accessory or ammunition
- 25 that is retained in this Commonwealth.
- 26 Section 5. Effective date.
- 27 This act shall take effect in 60 days.
