## AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, in criminal history record
- information, further providing for expungement.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 9122(a) and (c) of Title 18 of the
- 7 Pennsylvania Consolidated Statutes are amended to read:
- 8 § 9122. Expungement.
- 9 (a) Specific proceedings. -- Criminal history record
- 10 information shall be expunged in a specific criminal proceeding
- 11 when:
- 12 (1) no disposition has been received or, upon request
- 13 for criminal history record information, no disposition has
- 14 been recorded in the repository within 18 months after the
- date of arrest and the court of proper jurisdiction certifies
- 16 to the director of the repository that no disposition is
- 17 available and no action is pending. Expungement shall not

- occur until the certification from the court is received and the director of the repository authorizes such expungement;
- 3 (2) a court order requires that such nonconviction data 4 be expunged; [or]
  - (2.1) a person is pardoned unconditionally for the offense at issue in accordance with law; or
- 7 a person 21 years of age or older who has been 8 convicted of a violation of section 6308 (relating to 9 purchase, consumption, possession or transportation of liquor 10 or malt or brewed beverages), which occurred on or after the 11 day the person attained 18 years of age, petitions the court 12 of common pleas in the county where the conviction occurred 13 seeking expungement and the person has satisfied all terms 14 and conditions of the sentence imposed for the violation, 15 including any suspension of operating privileges imposed 16 pursuant to section 6310.4 (relating to restriction of 17 operating privileges). Upon review of the petition, the court 18 shall order the expungement of all criminal history record 19 information and all administrative records of the Department 20 of Transportation relating to said conviction.

- 22 (c) Maintenance of certain information required or
- 23 authorized. -- Notwithstanding any other provision of this
- 24 chapter, the prosecuting attorney and the central repository
- 25 shall, and the court may, maintain a list of the names and other
- 26 criminal history record information of persons whose records are
- 27 required by law or court rule to be expunged where the
- 28 [individual] person has successfully completed the conditions of
- 29 any pretrial or post-trial diversion or probation program [or]\_\_\_
- 30 where the person has been pardoned or where the court has

- 1 ordered expungement under this section. Such information shall
- 2 be used solely for the purposes of determining subsequent
- 3 eligibility for such programs, identifying persons in criminal
- 4 investigations or determining the grading of subsequent
- 5 offenses. Such information shall be made available to any court
- 6 or law enforcement agency upon request.

- 8 Section 2. This act shall take effect in 60 days.
