## A RESOLUTION

- 1 Directing the Joint State Government Commission to establish an
- advisory committee to conduct a study on mental health
- 3 services, including the identification and treatment of
- 4 mental illness, for individuals under the age of 21 in this
- 5 Commonwealth.
- 6 WHEREAS, All citizens deserve to be safe in their communities
- 7 and, most of all, children deserve to be safe in their schools
- 8 to focus on the learning process; and
- 9 WHEREAS, Gun violence in the form of mass shootings,
- 10 particularly in school settings, suggests, in part, a need to
- 11 examine the mental health system to determine if needs are going
- 12 unmet; and
- 13 WHEREAS, A 2014 study by the Joint State Government
- 14 Commission examined the overall system of delivery of mental
- 15 health services, focusing largely on the adult and prison
- 16 populations; and
- WHEREAS, Current mental health needs for individuals under 21
- 18 years of age and whether any mental health needs are going unmet

- 1 should be studied; and
- 2 WHEREAS, Preparations to address unmet needs for mental
- 3 health services should be examined before another act of
- 4 dangerous behavior caused by mental illness occurs; therefore be
- 5 it
- 6 RESOLVED, That the House of Representatives direct the Joint
- 7 State Government Commission to establish an advisory committee
- 8 to conduct a study on unmet needs for mental health services,
- 9 including the identification and treatment of mental illness,
- 10 for individuals under 21 years of age in this Commonwealth; and
- 11 be it further
- 12 RESOLVED, That the advisory committee consist of a
- 13 representative from each of the following:
- 14 (1) The Department of Education.
- 15 (2) The Department of Human Services.
- 16 (3) The Office of Attorney General.
- 17 (4) The Pennsylvania State Police.
- 18 (5) The American Civil Liberties Union.
- 19 (6) The Rehabilitation and Community Providers
- 20 Association.
- 21 (7) The School Superintendents Association.
- 22 (8) The Pennsylvania State Education Association.
- 23 (9) Law enforcement.
- 24 (10) A child advocacy group.
- 25 (11) A special education advocacy group.
- 26 (12) Any other experts who are deemed necessary for the
- 27 study by the Joint State Government Commission;
- 28 and be it further
- 29 RESOLVED, That the Joint State Government Commission submit a
- 30 report to the House of Representatives with its findings and

- 1 recommendations no later than one year after the adoption of
- 2 this resolution.
