Amending Titles 18 (Crimes and Offenses) and 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in firearms and other dangerous articles, further providing for prohibited conduct during emergency; and, in Commonwealth 4 services, further providing for general authority of 5 Governor. 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 9 Section 1. Section 6107 of Title 18 of the Pennsylvania 10 Consolidated Statutes is amended to read: 11 § 6107. Prohibited conduct during emergency. (a) General rule. -- No person shall carry a firearm upon the 12 public streets or upon any public property during an emergency 13 14 proclaimed by a State or municipal governmental executive unless 15 that person is: 16 Actively engaged in a defense of that person's life or property from peril or threat. 17

- 4 (b) Seizure, taking and confiscation.--[Except as otherwise
- 5 provided under subsection (a) and notwithstanding]
- 6 Notwithstanding the provisions of 35 Pa.C.S. Ch. 73 (relating to
- 7 Commonwealth services) or any other provision of law to the
- 8 contrary, no firearm, accessory or ammunition may be seized,
- 9 taken or confiscated during an emergency unless the seizure,
- 10 taking or confiscation would be authorized absent the emergency.
- 11 (c) Definitions. -- As used in this section, the following
- 12 words and phrases shall have the meanings given to them in this
- 13 subsection:
- "Accessory." Any scope, sight, bipod, sling, light,
- 15 magazine, clip or other related item that is attached to or
- 16 necessary for the operation of a firearm.
- 17 "Firearm." The term includes any weapon that is designed to
- 18 or may readily be converted to expel any projectile by the
- 19 action of an explosive or the frame or receiver of any weapon.
