- 30 (a) General rule. -- The commission may institute Sunday

- 1 <u>hunting by regulation promulgated in accordance with section</u>
- 2 2102 (relating to regulations).
- 3 (b) Applicability.--It shall be lawful for a person to hunt
- 4 for any furbearer or game on Sunday on and after the publication
- 5 of the final regulation under subsection (a).
- 6 Section 3. Section 2314 of Title 34 is amended to read:
- 7 § 2314. Trespass on private property while hunting.
- 8 [(a) General rule. -- Any person who while violating any
- 9 provision of this title or any regulations promulgated under
- 10 this title and who in addition is found to be trespassing as
- 11 defined in 18 Pa.C.S. § 3503 (relating to criminal trespass)
- 12 shall be in violation of this section.
- (b) Penalty. -- A violation of this section:
- 14 (1) A violation of this section is a summary offense of
- the fifth degree.
- 16 (2) A second or subsequent violation of this section
- 17 within a seven-year period is a summary offense of the fifth
- degree and may result in forfeiture of the privilege to hunt
- or take game or wildlife anywhere within this Commonwealth
- for a period of one year.]
- 21 (a) General rule. -- A person, while engaged in hunting or
- 22 furtaking, commits an offense if, knowing that the person is not
- 23 licensed or privileged to do so, the person:
- (1) enters or remains on any land of another without
- 25 authorization to do so, when the land is posted in a manner
- 26 prescribed by law or reasonably likely to come to the
- 27 person's attention or is fenced or enclosed in a manner
- 28 manifestly designed to exclude trespassers; or
- 29 (2) enters or remains on any land of another without
- 30 <u>authorization and defies an order not to enter or to leave</u>

- that has been personally communicated to the person by the
- 2 <u>owner of the land or other authorized person.</u>
- 3 (b) Penalty. -- An offense under this section shall be graded
- 4 as follows:
- 5 (1) A person who violates subsection (a) (1) commits a
- 6 summary offense of the third degree.
- 7 (2) A person who violates subsection (a) (2) commits a
- 8 <u>misdemeanor</u>.
- 9 (3) A person who commits a second or subsequent
- violation of this section within a seven-year period commits
- 11 <u>a misdemeanor, and the second or subsequent violation shall</u>
- 12 <u>result in forfeiture of the privilege to hunt or take game or</u>
- 13 <u>wildlife anywhere within this Commonwealth for a period of</u>
- one year.
- 15 Section 4. This act shall take effect in 60 days.
