AN ACT

- 1 Providing for COVID 19 guidelines EXTENSION OF COVID-19 WAIVER <-2 PROVISIONS for outdoor sportsman clubs.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the COVID-19
- 7 Emergency Outdoor Sportsman Club Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Clubhouse." An inside area at an outdoor sportsman club <--
- 13 where individuals gather and food and beverages may be served.
- 14 "COVID-19." The novel coronavirus identified in the
- 15 proclamation of disaster emergency issued by the Governor on
- 16 March 6, 2020, published at 50 Pa.B. 1644 (March 21, 2020), and

- 1 any renewal of the state of disaster emergency.
- 2 "Department." The Department of Health of the Commonwealth. <--
- 3 "Outdoor sportsman club." An association or club where
- 4 members and the public gather that has a shooting range.
- 5 "Range." An archery range, handgun shooting range, rifle
- 6 shooting range or shotgun range.
- 7 Section 3. COVID-19 quidelines for outdoor sportsman clubs.
- 8 All outdoor sportsman clubs in this Commonwealth that choose
- 9 to remain open during the COVID-19 emergency shall:
- 10 (1) Impose social distancing and mask requirements in
- 11 accordance with the department's COVID-19 guidelines.
- 12 (2) Only permit five shooters in each range at a time.
- 13 (3) Close a clubhouse associated with the outdoor-
- 14 sportsman club in order to adhere to the department's COVID-
- 15 19 quidelines.
- 16 SECTION 3. EXTENSION OF COVID-19 WAIVER PROVISIONS.
- 17 THE SECRETARY OF COMMUNITY AND ECONOMIC DEVELOPMENT SHALL
- 18 IMMEDIATELY ISSUE A WAIVER TO THE GOVERNOR'S 20200319 TWW COVID-

- 19 19 BUSINESS CLOSURE ORDER TO ALL OUTDOOR SPORTSMAN CLUBS THAT
- 20 CAN ADHERE TO THE SOCIAL DISTANCING PRACTICES, MASK REQUIREMENTS
- 21 AND OTHER MITIGATION MEASURES DEFINED BY THE CENTERS FOR DISEASE
- 22 CONTROL AND PREVENTION TO PROTECT INDIVIDUALS AND TO MITIGATE
- 23 THE SPREAD OF THE COVID-19 VIRUS.
- 24 Section 4. Effective date.
- This act shall take effect immediately.
