1 2 3 4	Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in firearms and other dangerous articles, providing for prohibited conduct during public demonstrations.
5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Title 18 of the Pennsylvania Consolidated
8	Statutes is amended by adding a section to read:
9	§ 6107.1. Prohibited conduct during public demonstrations.
10	(a) General ruleNotwithstanding any other provision of
11	this chapter or any other law or regulation to the contrary, no
12	person, other than a person enumerated in section 6106(b)(1),
13	(2), (3) and (13) (relating to firearms not to be carried
14	without a license), may:
15	(1) have in the person's possession, or immediate access
16	to, including in a vehicle, a firearm or other dangerous
17	article while participating in or attending a public
18	demonstration held at a public place in this Commonwealth; or

1	(2) have in the person's possession or have in a vehicle	
2	<u>at a point within 1,000 feet of a demonstration at a public</u>	
3	place in this Commonwealth a firearm or other dangerous	
4	article after having been:	
5	(i) advised by a law enforcement officer that a	
6	demonstration is taking place at the public place; and	
7	(ii) ordered by the law enforcement officer to	
8	vacate the public place until the person is no longer in	
9	possession of a firearm or dangerous article.	
10	(b) ExceptionThis section shall not apply to a person in	
11	possession of a firearm or other dangerous article in a private	
12	<u>dwelling or place of business.</u>	
13	(c) PenaltyA person who violates this section commits a	
14	felony of the third degree.	
15	(d) DefinitionsAs used in this section, the following	
16	words and phrases shall have the meanings given to them in this	
17	subsection unless the context clearly indicates otherwise:	
18	"Dangerous article." An offensive weapon, as defined under	
19	section 908 (relating to prohibited offensive weapons), a	
20	hatchet, ax, slingshot, nightstick, mace, pepper spray, iron	
21	buckle, baseball bat, ax handle, chains, crowbar, hammer or	
22	other club or bludgeon or any other weapon or instrument	
23	customarily used or intended for probable use as an offensive	
24	weapon.	
25	"Firearm." As defined under section 908, whether the firearm	
26	is loaded or unloaded. The term shall include an air rifle or	
27	<u>air pistol.</u>	
28	"Law enforcement officer." A duly appointed and acting	
29	Federal, State or local peace officer who, by virtue of the	
30	officer's office or public employment, is vested by law with the

1	duty to maintain public order or to make arrests for offenses or
2	any person on active State duty under 51 Pa.C.S. § 508 (relating
3	to active duty for emergency).
4	"Public demonstration." The assembly of two or more persons
5	for the purpose of picketing, speechmaking, marching, holding
6	vigils or other form of conduct or civil discourse that has the
7	effect, intent or propensity to attract other individuals or
8	onlookers, regardless of whether a political subdivision has
9	issued a permit authorizing the demonstration.

10 Section 2. This act shall take effect immediately.
