Amending Title 18 (Crimes and Offenses) of the Pennsylvania

Consolidated Statutes, in general provisions, providing for inflation adjustment; in theft and related offenses, further 2 3 providing for the offenses of retail theft, of library theft and of theft of secondary metal; and, in trade and commerce, further providing for buying or exchanging Federal 6 Supplemental Nutrition Assistance Program (SNAP) benefit coupons, stamps, authorization cards or access devices. 8 The General Assembly of the Commonwealth of Pennsylvania 9 10 hereby enacts as follows: Section 1. Title 18 of the Pennsylvania Consolidated 11 12 Statutes is amended by adding a section to read: 1.3 § 113. Inflation adjustment. Beginning March 1, 2024, and on March 1 of every fifth year 14 15 thereafter, the value of property or services as elements of an offense under this title shall increase at the rate of inflation 16 17 as outlined in the Consumer Price Index for All Urban Consumers 18 (CPI-U) for the Pennsylvania, New Jersey, Delaware and Maryland 19 area, for the five most recent 12-month periods for which 20 figures have been officially reported by the United States

Department of Labor. The determinations and adjustments required

- 1 under this section shall be made in the period between October 1
- 2 and November 15 of the year prior to the effective date of the
- 3 adjustment. Any change to a value shall be rounded up to the
- 4 next \$10. If the rate of inflation, as outlined in the Consumer
- 5 Price Index for All Urban Consumers (CPI-U) for the
- 6 Pennsylvania, New Jersey, Delaware and Maryland area, does not
- 7 <u>increase</u>, all values shall remain the same as they were for the
- 8 previous five-year period. The percentage increase and the value
- 9 <u>amounts shall be determined by the Pennsylvania Commission on</u>
- 10 Crime and Delinquency and shall be published by the Chairman of
- 11 the Pennsylvania Commission on Crime and Delinquency on the
- 12 <u>publicly accessible Internet website of the Pennsylvania</u>
- 13 Commission on Crime and Delinquency and transmitted to the
- 14 <u>Legislative Reference Bureau for publication in the next</u>
- 15 <u>available issue of the Pennsylvania Bulletin no fewer than 90</u>
- 16 days prior to the effective date of the adjustment.

- obtained is \$200 or more but less than [\$1,000] <u>\$2,000</u>, the
- 2 offense constitutes a misdemeanor of the first degree.

- 4 obtained is [\$1,000] \$2,000 or more, the offense constitutes
- 5 a felony of the third degree.

- 7 § 7313. Buying or exchanging Federal Supplemental Nutrition
- 8 Assistance Program (SNAP) benefit coupons, stamps,
- 9 authorization cards or access devices.

- 11 (b) Grading. -- A person who violates this section commits a
- 12 felony of the third degree if the amount involved is [\$1,000]
- 13 $\frac{$2,000}{}$ or more. If the amount involved is less than [\$1,000]
- 14 $\frac{$2,000}{}$, the person commits a misdemeanor of the first degree.
- 15 Amounts involved in buying or exchanging Federal SNAP benefit
- 16 coupons, stamps, authorization cards or access devices committed
- 17 pursuant to one scheme or course of conduct, whether from the
- 18 same person or several persons, shall be aggregated in
- 19 determining the grade of the offense.
