| 22 | (c) <u>The following shall apply:</u> |
| 23 | (1) Vouchers or copies of vouchers for all sums expended |
| 24 | amounting to more than twenty-five dollars (\$25) shall be |

retained by the candidate or the committee treasurer and shall
 be available for public inspection and copying as herein
 provided.

4 (2) Any person may inspect or copy such vouchers or copies
5 thereof by filing a written request with the appropriate
6 supervisory office which shall notify the candidate or political
7 committee of such request.

8 (3) The candidate or political committee shall have the 9 option of either forwarding such vouchers or copy of the same to 10 the supervisor for such purpose or making the vouchers or copy 11 of the same available to the requesting person.

12 (4) If a candidate or a treasurer of a political committee 13 shall fail to make said vouchers or copies thereof available for 14 inspection and copying when requested by the appropriate 15 supervisory officer, such officer shall [direct] order the 16 candidate or political committee to [promptly] deliver the 17 vouchers or copies thereof to the supervisory office within two 18 (2) days for purposes of inspection and copying.

19 (5) If the candidate or the treasurer of the political

20 committee fails to deliver the vouchers or copies within two (2)

21 days of the order under clause (4), the Secretary of the

22 <u>Commonwealth shall impose an administrative penalty of no more</u>

23 than five hundred dollars (\$500) on the candidate or the

24 political committee for each day the candidate or the treasurer

25 of the political committee fails to comply with the order.

26 (6) If the candidate or the treasurer of the political

27 committee fails to deliver the vouchers or copies within thirty

28 (30) days after the imposition of the administrative penalty

29 under clause (5), the Secretary of the Commonwealth shall refer_

30 the matter to the Attorney General for investigation.
