## AN ACT

Amending the act of July 9, 1987 (P.L.220, No.39), entitled "An <-act licensing and regulating the practice of social work; 2 providing penalties; and making an appropriation," further 3 providing for definitions, for license required, for State-Board of Social Workers, Marriage and Family Therapists and 5 Professional Counselors, for powers and functions of board, for qualifications for license, for procedures for licensing, for reciprocity and for reinstatement of license; providing 8 for restrictions on use of title "Licensed Associate Marriage 9 and Family Therapist"; and further providing for penalties, 10 11 for license renewal and records and fees and for unlawful 12 AMENDING THE ACT OF JULY 9, 1987 (P.L.220, NO.39), ENTITLED "AN <--13 ACT LICENSING AND REGULATING THE PRACTICE OF SOCIAL WORK; 14 PROVIDING PENALTIES; AND MAKING AN APPROPRIATION," FURTHER 15 PROVIDING FOR DEFINITIONS, FOR LICENSE REQUIRED, FOR STATE 16 BOARD OF SOCIAL WORKERS, MARRIAGE AND FAMILY THERAPISTS AND 17 PROFESSIONAL COUNSELORS, FOR POWERS AND FUNCTIONS OF BOARD, 18 FOR QUALIFICATIONS FOR LICENSE, FOR PROCEDURES FOR LICENSING, 19 FOR RECIPROCITY, FOR ENDORSEMENT OF OUT-OF-STATE LICENSES AND 20 FOR REINSTATEMENT OF LICENSE; PROVIDING FOR RESTRICTIONS ON 21 USE OF TITLE "LICENSED ASSOCIATE MARRIAGE AND FAMILY 22 THERAPIST" AND FOR RESTRICTIONS ON THE USE OF TITLE "LICENSED 23 ASSOCIATE PROFESSIONAL COUNSELOR"; FURTHER PROVIDING FOR 24 LICENSE RENEWAL AND RECORDS AND FEES AND FOR UNLAWFUL 25 PRACTICE; AND PROVIDING FOR EFFECT OF ASSOCIATE LICENSURE. 27 The General Assembly of the Commonwealth of Pennsylvania

28 hereby enacts as follows:

- 1 Section 1. Section 3 of the act of July 9, 1987 (P.L.220,

- 10 "Licensed associate marriage and family therapist." An-
- 11 <u>individual licensed as an associate marriage and family</u>
- 12 <u>therapist under this act who is obtaining experience under</u>
- 13 professional direct supervision for the purpose of becoming
- 14 <u>licensed as a marriage and family therapist.</u>
- 15 \* \* \*
- 16 "Practice of associate marriage and family therapy." The
- 17 professional application of psychotherapeutic and family systems
- 18 theories and techniques to the evaluation, assessment, diagnosis
- 19 and treatment of mental and emotional disorders, whether
- 20 cognitive, affective or behavioral, while under direct clinical
- 21 supervision of a licensed supervisor approved by the American
- 22 Association of Marriage and Family Therapy. The term includes
- 23 the evaluation and assessment of mental and emotional disorders
- 24 in the context of significant interpersonal relationships and
- 25 <u>the delivery of psychotherapeutic services to individuals</u>,
- 26 couples and families.

- Section 2. Sections 4, 5(1) and 6(2) and (3) of the act are

- 30 Section 4. License required.

- 1 It shall be unlawful for any person to hold himself or
  2 herself forth as a licensed bachelor social worker, licensed
- 3 social worker, licensed clinical social worker, licensed
- 4 <u>associate marriage and family therapist</u> licensed marriage and
- 5 family therapist or licensed professional counselor unless he or-
- 6 she shall first have obtained a license pursuant to this act.
- 7 Section 5. State Board of Social Workers, Marriage and Family
- 8 Therapists and Professional Counselors.

- 10 (1) Operating procedures. The board shall meet within 30
- 11 days after the appointment of its new members and set up-
- 12 operating procedures and develop application forms for licensing-
- 13 clinical social workers, associate marriage and family
- 14 therapists, marriage and family therapists and professional
- 15 counselors. It shall be the responsibility of the board to-
- 16 circulate these forms and educate the public to the requirements
- 17 of licensing in order to hold oneself out as a licensed bachelor-
- 18 social worker, licensed social worker, licensed clinical social
- 19 worker, licensed associate marriage and family therapist,
- 20 licensed marriage and family therapist or licensed professional-
- 21 counselor within the Commonwealth.
- 22 Section 6. Powers and functions of board.
- 23 The board shall have the following powers:

- 25 (2) To adopt and, from time to time, revise such rules
- 26 and regulations as may be necessary to carry into effect the
- 27 provisions of this act. Such regulations may include, but-
- 28 shall not be limited to, standards of professional practice

- 30 social workers, licensed clinical social workers, licensed

27	license. An associate marriage and family therapist license
28	shall expire six years after issuance and shall permanently
29	expire 30 days after completion of the required clinical
30	supervised hours under subsection (e)(2). The board may renew an

- 2 two years under extenuating circumstances or for good cause
- 3 shown.
- 4 <u>(e.3) Limitations on associate marriage and family therapist</u>
- 5 license. A licensed associate marriage and family therapist
- 6 <u>shall work under the supervision of a licensed marriage and</u>
- 7 family therapist who holds a clinical supervisor license to
- 8 supervise and direct the activities of the licensed associate
- 9 marriage and family therapist. Licensed associate marriage and
- 10 family therapists may not practice in a private setting without
- 11 the direct supervision of a licensed marriage and family
- 12 <u>therapist clinical supervisor</u>. Nothing in this section shall be
- 13 <u>construed to prohibit a licensed associate marriage and family</u>
- 14 therapist to take the National Association of Marriage and
- 15 <u>Family Therapy Regulatory Boards Exam during the time between</u>
- 16 graduation and completing the required clinical supervised hours
- 17 under subsection (e) (2) in order to meet licensure requirements.

- 23 (b) Issuance of license. The board shall issue to each
- 24 person who meets the licensure requirements of this act a
- 25 certificate setting forth that such person is licensed to hold
- 26 himself or herself out as a licensed bachelor social worker, a
- 27 licensed social worker, a licensed clinical social worker, a
- 28 licensed associate marriage and family therapist, a licensed
- 29 marriage and family therapist or a licensed professional

- 2 (a) General rule. The board shall have the power to grant a
- 3 reciprocal license to an applicant who is licensed or certified
- 4 as a bachelor social worker, social worker, clinical social
- 5 worker, associate marriage and family therapist, marriage and
- 6 family therapist or professional counselor in another state and
- 7 has demonstrated qualifications which equal or exceed those
- 8 required pursuant to this act in the determination of the board,
- 9 provided that no license shall be granted under this section to-
- 10 an applicant unless the state in which the applicant is licensed-
- 11 affords reciprocal treatment to persons who are residents of
- 12 this Commonwealth and who are licensed pursuant to this act.

- 14 Section 12. Reinstatement of license.
- 15 Unless ordered to do so by Commonwealth Court or an appeal
- 16 therefrom, the board shall not reinstate the license of a person-
- 17 to practice as a bachelor social worker, social worker, clinical
- 18 social worker, associate marriage and family therapist, marriage
- 19 and family therapist or professional counselor pursuant to this-
- 20 act, which has been revoked. Any person whose license has been
- 21 revoked may apply for reinstatement, after a period of at least-
- 22 five years, but must meet all of the licensing qualifications of
- 23 this act, including the examination requirement, if he or she
- 24 desires to practice as a bachelor social worker, social worker,
- 25 clinical social worker, marriage and family therapist or
- 26 professional counselor pursuant to this act at any time after
- 27 such revocation.
- 28 Section 5. The act is amended by adding a section to read:

- 1 Only individuals who have received licenses as licensed
- 2 <u>associate marriage and family therapists under this act may</u>
- 3 style themselves as licensed associate marriage and family
- 4 therapists and use the letters "L.A.M.F.T." in connection with
- 5 their names, and it shall be unlawful for an individual to style
- 6 <u>himself or herself as a licensed associate marriage and family</u>
- 7 therapist or use any words or symbols indicating or tending to
- 8 <u>indicate that the individual is a licensed associate marriage</u>
- 9 and family therapist without holding a license in good standing
- 10 under this act.

- 16 criminal penalty provided for in this act, the board, by a vote-
- 17 of the majority of the maximum number of the authorized

- 19 majority of the duly qualified and confirmed membership or a
- 20 minimum of three members, whichever is greater, may levy a civil-
- 21 penalty of up to \$10,000 on any current licensee who violates
- 22 any provision of this act, on any person who engages in the
- 23 independent practice of clinical social work, the independent
- 24 practice of marriage and family therapy or the independent
- 25 practice of professional counseling without being licensed
- 26 pursuant to this act or on any person who holds himself or
- 27 herself out as a licensed bachelor social worker, licensed
- 28 social worker, licensed clinical social worker, <u>licensed</u>
- 29 associate marriage and family therapist licensed marriage and
- 30 family therapist, licensed professional counselor or marriage

- 2 act. The board shall levy this penalty only after affording the
- 3 accused party the opportunity for a hearing, as provided in-
- 4 Title 2 of the Pennsylvania Consolidated Statutes (relating to-

- 9 (b) Records. -- A record of all persons licensed to practice
- 10 as bachelor social workers, social workers, clinical social

- 12 family therapists and professional counselors in Pennsylvania
- 13 shall be kept in the office of the board and shall be open to
- 14 public inspection and copying upon payment of a nominal fee for-
- 15 copying the record.

- 18 (a) Unlawful practice prohibited. It shall be unlawful for
- 19 any person to engage in the independent practice of clinical
- 20 social work, the independent practice of marriage and family
- 21 therapy or the independent practice of professional counseling-
- 22 or hold himself or herself out as a licensed bachelor social
- 23 worker, licensed social worker, licensed clinical social worker,
- 24 <u>licensed associate marriage and family therapist</u>, marriage and
- 25 family therapist and professional counselor without possessing a
- 26 valid, unexpired, unrevoked and unsuspended license issued under-
- 27 this act.

- 21 BASED THERAPEUTIC APPROACHES, SUCH AS ART, DANCE, MUSIC OR
- DRAMA, TO ACCOMPLISH TREATMENT OBJECTIVES.

- 10 CLINICAL SOCIAL WORKERS, ASSOCIATE MARRIAGE AND FAMILY
