## AN ACT

- Amending Title 18 (Crimes and Offenses) of the Pennsylvania 1 Consolidated Statutes, in general provisions, further 2 providing for definitions; in inchoate crimes, further 3 providing for prohibited offensive weapons and for possession of firearm or other dangerous weapon in court facility; in assault, further providing for assault of law enforcement officer and for discharge of firearm into an occupied 7 structure; in theft and related offenses, further providing 8 for definitions; in riot, disorderly conduct and related offenses, further providing for prohibiting of paramilitary 10 training; in firearms and other dangerous articles, further providing for definitions, for persons not to possess, use, 11 12 manufacture, control, sell or transfer firearms, for firearms 13 not to be carried without a license and for prohibited 14 conduct during emergency, providing for 3-D printed firearms and further providing for sale or transfer of firearms, for firearm sales surcharge, for registration of firearms, for 15 16 17 licensing of dealers and for abandonment of firearms, weapons 18 19 or ammunition.
