AN ACT

Amending Titles 30 (Fish) and 34 (Game) of the Pennsylvania Consolidated Statutes, in fishing licenses, providing for law enforcement; and, in hunting and furtaking licenses, further providing for resident license and fee exemptions and for license costs and fees.
The General Assembly of the Commonwealth of Pennsylvania
hereby enacts as follows:
Section 1. Title 30 of the Pennsylvania Consolidated
Statutes is amended by adding a section to read:
<u>§ 2707.3. Law enforcement.</u>
(a) EligibilityThe commission or a county treasurer shall
issue one annual resident fishing license at a cost of \$1 to any
person eligible for the license under section 2701 (relating to
resident fishing licenses) who provides documentation that the
person is employed as an officer in this Commonwealth.
(b) RegulationsThe commission may promulgate regulations
to implement this section.
(c) DefinitionsAs used in this section, the following
words and phrases shall have the meanings given to them in this
