AN ACT

1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
2 act relating to the public school system, including certain
3 provisions applicable as well to private and parochial
4 schools; amending, revising, consolidating and changing the
5 laws relating thereto," in certification of teachers,
6 repealing provisions relating to CPR instruction; in school
7 safety and security, further providing for School Safety and
8 Security Grant Program; and, in school health services,
9 further providing for definitions, repealing provisions
10 relating to automatic external defibrillators, providing for
11 AED and CPR instruction and procedure, establishing the
12 Automated External Defibrillator Program and providing for
13 availability and specifications of automated external
14 defibrillators.

15 This act shall be known and may be cited as Greg Moyer's Law.

16 The General Assembly of the Commonwealth of Pennsylvania
17 hereby enacts as follows:

18 Section 1. Section 1205.4 of the act of March 10, 1949
19 (P.L.30, No.14), known as the Public School Code of 1949, is
20 repealed:

21 [Section 1205.4. CPR Instruction.--(a) School entities
22 shall be required to offer a cardiopulmonary resuscitation

1 training (CPR) class on school premises at least once every
2 three years. The course shall be offered as an option to all
3 employes of the school entity.

4 (b) Completion of training, including testing of skills and
5 knowledge, shall be documented by the signature and title of a
6 representative of the training entity and shall include the date
7 training was completed. Documentation shall be retained in the
8 facility in that employe's file. Training shall be conducted by:

9 (1) the American Red Cross;

10 (2) the American Heart Association;

11 (3) an individual certified to conduct CPR training by the
12 American Red Cross, American Heart Association or other
13 certifying agency approved by the Department of Health; or

14 (4) other certifying agency approved by the Department of
15 Health.

16 (c) School districts may include this training in the
17 continuing education plan submitted by the district to the
18 Department of Education under section 1205.1.

19 (d) For purposes of this section, a school entity shall be
20 defined as a local school district, intermediate unit or area
21 career and technical school.]

uncommitted or unencumbered by the commission by September 30

(J) SPECIFIC PURPOSES.--THE COMMITTEE SHALL PROVIDE GRANTS

(12) SECURITY PLANNING AND PURCHASE OF SECURITY-RELATED

Section 3. Section 1401 of the act is amended by adding a
definition to read:

Section 1401. Definitions.--As used in this article--

* * *

(17) "Automated external defibrillator" or "AED" means a
portable device that uses electric shock to restore a stable

1 heart rhythm to an individual in cardiac arrest.

2 Section 4. Section 1423 of the act is repealed:

3 [Section 1423. Automatic External Defibrillators.--(a) The
4 department shall establish an automatic external defibrillator
5 program to assist school entities and nonpublic schools in
6 making automatic external defibrillators available in school
7 buildings.

8 (b) On a biennial basis, the department, in consultation
9 with the Department of General Services and the Department of
10 Health, shall issue an invitation to bid for the cost of
11 automatic external defibrillators and other equipment and
12 supplies necessary for the proper operation of the device. The
13 department shall accept the bid of the lowest responsible bidder
14 and permit any school entity or nonpublic school to purchase the
15 devices at the contract bid price. The department may purchase
16 automatic external defibrillators from any funds appropriated
17 pursuant to subsection (k) for distribution to school entities
18 and nonpublic schools.

19 (c) To be eligible to obtain or purchase automatic external
20 defibrillators under the program a school entity or nonpublic
21 school must:

22 (1) Assure that two (2) or more persons assigned to the
23 location where the automatic external defibrillator will be
24 primarily housed are trained as required in subsection (d).

25 (2) Ensure that the device will be secured in a safe and
26 readily accessible location and agree to properly maintain and
27 test the device according to the manufacturer's operational
28 guidelines.

29 (3) Submit a valid prescription for the device from a
30 licensed medical practitioner in this Commonwealth.

1 (4) Agree to provide the training required by subsection
2 (d).

3 (d) School personnel who are expected to use the automatic
4 external defibrillator shall complete training in
5 cardiopulmonary resuscitation and in the use of an automatic
6 external defibrillator provided by the American Heart
7 Association, the American Red Cross or through an equivalent
8 course of instruction approved by the Department of Health.

9 (e) A school entity may include the training required by
10 subsection (d) in its continuing professional education plan
11 submitted to the department under section 1205.1.

12 (f) The provisions of 42 Pa.C.S. § 8331.2 (relating to good
13 Samaritan civil immunity for use of automated external
14 defibrillator) shall apply to school employes who render care
15 with an automatic external defibrillator.

16 (g) From funds appropriated for this purpose, the department
17 may assist school entities and nonpublic schools that are not
18 equipped with automatic external defibrillators by providing a
19 discount from the contract bid price obtained under subsection
20 (b) or by providing automatic external defibrillators obtained
21 under subsection (b).

22 (g.1) The purchase of an automatic external defibrillator
23 shall be considered an allowable use of Pennsylvania
24 Accountability Grants under section 2599.2(b).

25 (g.2) The purchase of automatic external defibrillators
26 shall be considered an innovative educational program under
27 Article XVII-F of the act of March 4, 1971 (P.L.6, No.2), known
28 as the "Tax Reform Code of 1971."

29 (h) (Reserved).

30 (i) Not later than June 30, 2014, and each year thereafter,

1 each school entity shall make a report to the department
2 detailing the number, condition, age and placement of automatic
3 external defibrillators in each school building. After the
4 initial report is made, a school entity may report this
5 information as part of the annual report required by the
6 Commonwealth under section 2505.1 to receive State reimbursement
7 for health services.

8 (i.1) A nonpublic school that participates in the automatic
9 external defibrillator program under subsection (b) or (g) shall
10 be subject to the reporting required under subsection (i).

11 (i.2) The department shall annually publish a report on its
12 publicly accessible Internet website no later than December 31,
13 2014, and each year thereafter. The report shall contain the
14 following information:

15 (1) The total number of automatic external defibrillators by
16 school entity and nonpublic school.

17 (2) The number of school buildings by school entity and
18 nonpublic school that are equipped with automatic external
19 defibrillators.

20 (3) The number of school buildings by school entity and
21 nonpublic school that are not equipped with automatic external
22 defibrillators.

23 (j) The department may adopt guidelines as necessary to
24 administer this section.

25 (k) The General Assembly may appropriate funds to carry out
26 the provisions of this section.

27 (l) As used in this section--

28 "Automatic external defibrillator" means a portable device
29 that uses electric shock to restore a stable heart rhythm to an
30 individual in cardiac arrest.

1 "Department" means the Department of Education of the
2 Commonwealth.

3 "Nonpublic school" means a nonprofit school, other than a
4 public school within this Commonwealth, wherein a resident of
5 this Commonwealth may legally fulfill the compulsory school
6 attendance requirements of this act and which meets the
7 applicable requirements of Title VI of the Civil Rights Act of
8 1964 (Public Law 88-352, 78 Stat. 241).

9 "School building" means a building owned by or under the
10 control of a school entity or nonpublic school where classes are
11 taught or extracurricular activities are conducted on a regular
12 basis.

13 "School entity" means an area career and technical school, a
14 charter school, a cyber charter school, an intermediate unit or
15 a school district.

16 "Secretary" means the Secretary of Education of the
17 Commonwealth.]

18 Section 5. The act is amended by adding sections to read:

19 Section 1423.1. AED and CPR Instruction and Procedure.--(a)
20 Each school entity and nonpublic school shall make available to
21 its ITS employes and volunteers instruction in the principles <--
22 and techniques of cardiopulmonary resuscitation and the use of
23 an automated external defibrillator on school premises at least
24 once every two years. The following apply:

25 (1) The instruction shall be offered as an option to all
26 school entity employes and volunteers.

27 (2) The instruction shall be conducted by any of the
28 following:

29 (i) The American Red Cross.

30 (ii) The American Heart Association.

1 (iii) National Safety Council.

2 (iv) An individual certified to conduct CPR training by the
3 American Red Cross, American Heart Association or other
4 certifying agency approved by the Department of Health.

5 (v) Another certifying agency approved by the Department of
6 Health.

7 (3) A school entity and nonpublic school may provide the
8 instruction under this section through the Internet or other
9 electronic means.

10 (b) The following apply to AED ~~locations and training:~~ <--

11 INSTRUCTION: <--

12 (1) EACH SCHOOL ENTITY SHALL ENSURE THAT AT LEAST ONE (1)
13 INDIVIDUAL TRAINED AND CERTIFIED IN THE USE OF AN AED AND CPR IS
14 PRESENT IN EACH SCHOOL BUILDING DURING EACH SCHOOL DAY.

15 (2) EACH SCHOOL NURSE OR DESIGNEE, COACH OF AN ATHLETIC
16 ACTIVITY, MARCHING BAND DIRECTOR, PHYSICAL EDUCATION TEACHER AND
17 ATHLETIC TRAINER WITHIN EACH SCHOOL ENTITY MUST PARTICIPATE IN
18 THE INSTRUCTION IN THE USE OF AN AED AND CPR.

19 (3) AN INDIVIDUAL DESCRIBED IN THIS SUBSECTION MUST COMPLETE
20 THE INSTRUCTION AND MAINTAIN CERTIFICATION IN THE USE OF AN AED
21 IN ACCORDANCE WITH THIS SECTION.

22 (C) THE FOLLOWING APPLY TO AED LOCATIONS AND TRAINING:

23 (1) Each school entity and nonpublic school that
24 participates in interscholastic athletics, as defined in section
25 1602-A, shall ensure that at each AED location there are
26 individuals trained and certified in CPR and in the use of an
27 AED by an entity listed under subsection (a)(2).

28 (2) Training must be completed and certification maintained
29 in the use of an AED in accordance with this section.

30 (3) Each school entity and nonpublic school that

1 participates in interscholastic athletics shall ensure that the
2 individuals trained in the use of an AED have access to the AED
3 on the premises of the school entity and nonpublic school.

5 requirements:

6 (1) A school entity may include the training under this
7 section in the continuing education plan submitted to the
8 department under section 1205.1.

9 (2) Satisfying the education requirements of this section
10 shall also satisfy the education requirements under section

13 the testing of skills and knowledge, shall be documented by the
14 signature and title of a representative of the training entity
15 and shall include the date that the training was completed. The

18 completed the training.

24 (f) The following apply to a cardiac emergency response
25 plan:

26 (1) Each school entity and nonpublic school that
27 participates in interscholastic athletics shall develop or amend
28 an existing cardiac emergency response plan that includes:

29 (i) Nationally recognized evidence-based core elements or
30 standards.

1 (ii) An annual review.

2 (iii) Safety procedures to follow in response to a medical
3 emergency involving cardiac arrest and the use of an AED.

4 (iv) The placement of AEDs on school premises and athletic
5 fields.

6 (v) The number of individuals who must receive training.

7 (2) The cardiac emergency response plan of each school
8 entity and nonpublic school shall:

9 (i) ~~Provide~~ MAKE AVAILABLE cardiac awareness information to <--
10 ~~be distributed annually to~~ school entity and nonpublic school <--
11 employees and those responsible for extracurricular activities,
12 community group activities, summer or other programs using the
13 facilities of the school entity.

15 with or without the participation of students to test the

8 TAUGHT OR EXTRACURRICULAR ACTIVITIES ARE CONDUCTED ON A REGULAR
9 BASIS.

10 "SCHOOL DAY" MEANS THE LENGTH OF TIME THAT A CHILD SUBJECT TO
11 COMPULSORY SCHOOL ATTENDANCE IS EXPECTED TO BE RECEIVING
12 INSTRUCTION DURING A CALENDAR DAY AS DETERMINED BY THE GOVERNING
13 BODY.

14 "School entity" means a school district, charter school,
15 regional charter school, cyber charter school, intermediate unit
16 or area career and technical school.

17 "Volunteer" means an individual who holds an unpaid position
18 with a school entity or nonpublic school as a volunteer for a
19 program, activity or service and is responsible for the welfare
20 of children or has direct volunteer contact.

21 Section 1423.2. Automated External Defibrillator Program.--

22 (a) The department shall establish the Automated External
23 Defibrillator Program to assist school entities and nonpublic
24 schools in making AEDs available in school buildings.

25 (b) On a biennial basis, the department, in consultation
26 with the Department of General Services and the Department of
27 Health, shall issue an invitation to bid for the cost of AEDs
28 and other equipment and supplies necessary for the proper
29 operation of the device. The department shall accept the bid of
30 the lowest responsible bidder and permit any school entity or

1 nonpublic school to purchase the devices at the contract bid
2 price. The department may provide AEDs from any money made <--
3 available under section 1306 B(h) (4) and (13) for distribution
4 to school entities and may loan the AEDs free of charge to
5 nonpublic schools. THE GENERAL ASSEMBLY MAY APPROPRIATE FUNDS TO <--
6 CARRY OUT THE PROVISIONS OF THIS SECTION.

7 (c) To be eligible to obtain, purchase or loan AEDs under
8 the program, a school entity or nonpublic school must:

9 (1) Comply with the provisions in section 1423.1.

10 (2) Ensure that the AED will be secured in a safe and
11 readily accessible location and agree to properly maintain and
12 test the device according to the manufacturer's operational
13 guidelines.

14 (d) The provisions of 42 Pa.C.S. § 8331.2 (relating to good
15 Samaritan civil immunity for use of automated external
16 defibrillator) shall apply to school entity and nonpublic school
17 employees who render care with an AED.

18 (e) From money made available for this purpose under section <--
19 1306 B(h) (4) and (13), the THE department may assist school <--
20 entities and nonpublic schools that are not equipped with the
21 necessary number of AEDs by providing a discount from the
22 contract bid price obtained under subsection (b) or by providing
23 or loaning AEDs under subsection (b).

24 (f) The purchase of an AED shall be considered an allowable <--
25 use of Pennsylvania Accountability Grants under section
26 2599.2(b).

27 (g) The purchase of AEDs shall be considered an innovative
28 educational program under Article XX B.

29 (h) The purchase of AEDs shall be considered an eligible
30 school safety and security expense in section 1306 B(j).

5 Section 1423.3. Availability and Specifications of Automated
6 External Defibrillators.--(a) Each school entity and nonpublic
7 school that participates in interscholastic athletics, as
8 defined in section 1602-A, shall have an automated external
9 defibrillator situated in such a manner that is readily
10 accessible for students participating in interscholastic
11 athletics and practices.

12 (b) Nothing in this section shall be construed as
13 establishing any liability for or a cause of action against a
14 school entity or nonpublic school or its officers, VOLUNTEERS <--
15 or employes.

16 (c) The provisions of 42 Pa.C.S. § 8331.2 (relating to good
17 Samaritan civil immunity for use of automated external
18 defibrillator) shall apply to school entity or nonpublic school
19 employes AND VOLUNTEERS who render care with an AED. <--

20 (d) Each school entity or nonpublic school shall ensure that
21 each AED is properly tested and maintained in accordance with
22 the manufacturer's operational guidelines. Each AED in a school
23 entity or nonpublic school shall meet the most recent minimum
24 specifications as required by the Department of Health.

25 (e) As used in this section, the following words and phrases
26 shall have the meanings given to them in this subsection unless
27 the context clearly indicates otherwise:

28 "AUTOMATED EXTERNAL DEFIBRILLATOR" OR "AED" MEANS AS DEFINED <--

2 Section 6. School entities and nonpublic schools shall
