- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "National Heritage
- 3 Area Act".
- 4 SEC. 2. NATIONAL HERITAGE AREA SYSTEM.
- 5 (a) In General.—Subtitle I of title 54, United
- 6 States Code, is amended by adding at the end the fol-
- 7 lowing:

7	NENTS.—The National Heritage Area System shall be
8	composed of—
9	"(1) each National Heritage Area, National
10	Heritage Corridor, National Heritage Canalway,
11	Cultural Heritage Corridor, National Heritage
12	Route, and National Heritage Partnership des-
13	ignated by Congress before or on the date of enact-
14	ment of this chapter; and
15	"(2) each National Heritage Area designated by
16	Congress after the date of enactment of this chapter.
17	"(c) Relationship to the System.—
18	"(1) RELATIONSHIP TO SYSTEM UNITS.—The
19	Secretary shall—
20	"(A) ensure, to the maximum extent prac-
21	ticable, participation and assistance by any ad-
22	ministrator of the System unit that is located
23	near or encompassed by a National Heritage
24	Area in local initiatives for the National Herit-
25	age Area to conserve and interpret resources

1	consistent with the applicable management plan
2	for the National Heritage Area; and
3	"(B) work with local coordinating entities
4	to promote public enjoyment of System units
5	and System-related resources.

8	Heritage Areas, in partnership with local coordi-
9	nating entities; and
10	"(5) provide national oversight, analysis, coordi-
11	nation, technical and financial assistance, and sup-
12	port to ensure consistency and accountability of the
13	National Heritage Area System.

17	"(3) REQUIREMENTS.—A study under para-
18	graph (1) shall include analysis, documentation, and
19	determinations on whether the proposed National
20	Heritage Area—
21	"(A) has an assemblage of natural, his-
22	toric, and cultural resources that—
23	"(i) represent distinctive aspects of
24	the heritage of the United States:

1	"(ii) are worthy of recognition, con-
2	servation, interpretation, and continuing
3	use; and
4	"(iii) would be best managed—
5	"(I) through partnerships among
6	public and private entities; and
7	"(II) by linking diverse and
8	sometimes noncontiguous resources
9	and active communities;
10	"(B) reflects traditions, customs, beliefs,
11	and folklife that are a valuable part of the story
12	of the United States;
13	"(C) provides outstanding opportunities—
14	"(i) to conserve natural, historic, cul-
15	tural, or scenic features; and
16	"(ii) for recreation and education;
17	"(D) contains resources that—
18	"(i) are important to any identified
19	themes of the proposed National Heritage
20	Area; and
21	"(ii) retain a degree of integrity capa-
22	ble of supporting interpretation;
23	"(E) includes a diverse group of residents,
24	business interests, nonprofit organizations, and
25	State and local governments that—

1	"(i) are involved in the planning of
2	the proposed National Heritage Area;
3	"(ii) have developed a conceptual fi-
4	nancial plan that outlines the roles of all
5	participants in the proposed National Her-
6	itage Area, including the Federal Govern-
7	ment; and
8	"(iii) have demonstrated significant
9	support for the designation of the proposed
10	National Heritage Area;
11	"(F) has a potential management entity to
12	work in partnership with the individuals and
13	entities described in subparagraph (E) to de-
14	velop the proposed National Heritage Area
15	while encouraging State and local economic ac-
16	tivity; and
17	"(G) has a conceptual boundary map that
18	is supported by the public.
19	"(4) Report.—
20	"(A) In general.—For each study car-
21	ried out under paragraph (1), the Secretary
22	shall submit to the Committee on Energy and
23	Natural Resources of the Senate and the Com-
24	mittee on Natural Resources of the House of
25	Representatives a report that describes—

1	"(i) any correspondence received by
2	the Secretary demonstrating support for,
3	or opposition to, the establishment of the
4	National Heritage Area;
5	"(ii) the findings of the study; and
6	"(iii) any conclusions and rec-
7	ommendations of the Secretary.
8	"(B) Timing.—
9	"(i) Studies carried out by the
10	SECRETARY.—With respect to a study car-
11	ried out by the Secretary in accordance
12	with paragraph (2)(A)(i), the Secretary
13	shall submit a report under subparagraph
14	(A) not later than 3 years after the date
15	on which funds are first made available to
16	carry out the study.
17	"(ii) Studies carried out by
18	OTHER INTERESTED PARTIES.—With re-
19	spect to a study carried out by interested
20	individuals or entities in accordance with
21	paragraph (2)(A)(ii), the Secretary shall
22	submit a report under subparagraph (A)
23	not later than 180 days after the date on
24	which the Secretary certifies under para-

1	graph (2)(B) that the study meets the re-
2	quirements of paragraph (3).
3	"(b) Designation.—An area shall be designated as
4	a National Heritage Area only by an Act of Congress.
5	"§ 120104. Evaluation
6	"(a) In General.—At reasonable and appropriate
7	intervals, as determined by the Secretary, the Secretary
8	may—
9	"(1) conduct an evaluation of the accomplish-
10	ments of a National Heritage Area in accordance
11	with subsection (b); and
12	"(2) prepare and submit to the Committee on
13	Energy and Natural Resources of the Senate and
14	the Committee on Natural Resources of the House
15	of Representatives a report that includes rec-
16	ommendations for the continued role of the Service
17	with respect to each National Heritage Area in ac-
18	cordance with subsection (c).
19	"(b) Components.—An evaluation under subsection
20	(a)(1) shall—
21	"(1) assess the progress of the applicable local
22	coordinating entity of a National Heritage Area with
23	respect to—
24	"(A) accomplishing the purposes of the ap-
25	plicable National Heritage Area; and

1	"(B) achieving the goals and objectives of
2	the management plan;
3	"(2) analyze Federal, State, local, Tribal gov-
4	ernment, and private investments in the National
5	Heritage Area to determine the leverage and impact
6	of the investments; and
7	"(3) review the management structure, partner-
8	ship relationships, and funding of the National Her-
9	itage Area for purposes of identifying the critical
10	components for sustainability of the National Herit-
11	age Area.
12	"(c) Recommendations.—Each report under sub-
13	section (a)(2) shall include—
14	"(1) if the report contains a recommendation of
15	the Secretary that Federal funding for the applicable
16	National Heritage Area should be continued, an
17	analysis of—
18	"(A) any means by which that Federal
19	funding may be reduced or eliminated over
20	time; and
21	"(B) the appropriate time period necessary
22	to achieve the recommended reduction or elimi-
23	nation of Federal funding; or
24	"(2) if the report contains a recommendation of
25	the Secretary that Federal funding for the applicable

1	National Heritage Area should be eliminated, a de-
2	scription of potential impacts on conservation, inter-
3	pretation, and sustainability in the applicable Na-
4	tional Heritage Area.".
5	(b) Private Property and Regulatory Protec-
6	TIONS.—
7	(1) In general.—Nothing in this section (in-
8	cluding an amendment made by this section)—
9	(A) abridges any right of a public or pri-
10	vate property owner, including the right to re-
11	frain from participating in any plan, project,
12	program, or activity conducted within a Na-
13	tional Heritage Area;
14	(B) requires any property owner to permit
15	public access (including Federal, State, Tribal
16	government, or local government access) to a
17	property;
18	(C) modifies any provision of Federal
19	State, Tribal, or local law with respect to public
20	access or use of private land;
21	(D)(i) alters any applicable land use regu-
22	lation, land use plan, or other regulatory au-
23	thority of any Federal, State, or local agency or
24	Tribal government; or

1	(ii) conveys to any local coordinating entity
2	any land use or other regulatory authority;
3	(E) authorizes or implies the reservation or
4	appropriation of water or water rights;
5	(F) diminishes the authority of a State to
6	manage fish and wildlife, including through the
7	regulation of fishing and hunting within a Na-
8	tional Heritage Area in the State; or
9	(G) creates or affects any liability—
10	(i) under any other provision of law;
11	or
12	(ii) of any private property owner with
13	respect to any person injured on private
14	property.
15	(2) Conforming Amendment.—Section

18	(a) Kaena Point National Heritage Area
19	STUDY.—The Secretary of the Interior (referred to in this
20	section as the "Secretary"), in consultation with State of
21	Hawaii and local historic preservation officers, State and
22	local historical societies, State and local tourism offices,
23	and other appropriate organizations and governmental

1	agencies and in accordance with section 120103(a) of title
2	54, United States Code, shall conduct a study to assess
3	the suitability and feasibility of designating all or a por-
4	tion of Honolulu County on the island of Oahu as a Na-
5	tional Heritage Area, to be known as the "Kaena Point
6	National Heritage Area".
7	(b) Great Dismal Swamp National Heritage
8	Area Study.—
9	(1) In general.—The Secretary, in consulta-
10	tion with State and local organizations and govern-
11	mental agencies, Tribal governments, nonprofit orga-
12	nizations, and other appropriate entities and in ac-
13	cordance with section 120103(a) of title 54, United
14	States Code, shall conduct a study to assess the
15	suitability and feasibility of designating the areas
16	described in paragraph (2) in the States of Virginia
17	and North Carolina as a National Heritage Area, to
18	be known as the "Great Dismal Swamp National
19	Heritage Area''.
20	(2) Description of study area.—The areas
21	to be studied under paragraph (1) include—
22	(A) the cities of Chesapeake, Norfolk
23	Portsmouth, and Suffolk in the State of Vir-
24	ginia;

1	(B) Isle of Wight County in the State of
2	Virginia;
3	(C) Camden, Currituck, Gates, and
4	Pasquotank Counties in the State of North
5	Carolina; and
6	(D) any other area in the State of Virginia
7	or North Carolina that—
8	(i) has heritage aspects that are simi-
9	lar to the heritage aspects of an area de-
10	scribed in subparagraph (A), (B), or (C);
11	and
12	(ii) is adjacent to, or in the vicinity of,
13	an area described in subparagraph (A),
14	(B), or (C).
15	(c) Guam National Heritage Area Study.—The
16	Secretary, in consultation with appropriate regional and
17	local organizations or agencies, and in accordance with
18	section 120103(a) of title 54, United States Code, shall
19	conduct a study to assess the suitability and feasibility of
20	designating sites in Guam as a National Heritage Area.
21	SEC. 4. NATIONAL HERITAGE AREA DESIGNATIONS.
22	(a) Designations.—Section 6001(a) of the John D.
23	Dingell, Jr. Conservation, Management, and Recreation
24	Act (Public Law 116–9; 133 Stat. 768) is amended by
25	adding at the end the following:

1	"(7) Alabama black belt national herit-
2	AGE AREA.—
3	"(A) In General.—There is established
4	the Alabama Black Belt National Heritage
5	Area in the State of Alabama, as depicted on
6	the map entitled 'Alabama Black Belt Proposed
7	National Heritage Area', numbered 258/
8	177,272, and dated September 2021.
9	"(B) Local coordinating entity.—The
10	Center for the Study of the Black Belt at the
11	University of West Alabama shall be the local
12	coordinating entity for the National Heritage
13	Area designated by subparagraph (A).
14	"(8) Bronzeville-black metropolis na-
15	TIONAL HERITAGE AREA, ILLINOIS.—
16	"(A) In General.—There is established
17	the Bronzeville-Black Metropolis National Her-
18	itage Area in the State of Illinois.
19	"(B) Boundaries.—The National Herit-
20	age Area shall consist of the region in the city
21	of Chicago, Illinois, bounded as follows:
22	"(i) 18th Street on the north to 22nd
23	Street on the south, from Lake Michigan
24	on the east to Wentworth Avenue on the
25	west.

1	"(ii) 22nd Street on the north to 35th
2	Street on the south, from Lake Michigan
3	on the east to the Dan Ryan Expressway
4	on the west.
5	"(iii) 35th Street on the north to 47th
6	Street on the south, from Lake Michigan
7	on the east to the B&O Railroad (Stewart
8	Avenue) on the west.
9	"(iv) 47th Street on the north to 55th
10	Street on the south, from Cottage Grove
11	Avenue on the east to the Dan Ryan Ex-
12	pressway on the west.
13	"(v) 55th Street on the north to 67th
14	Street on the south, from State Street on
15	the west to Cottage Grove Avenue/ South
16	Chicago Avenue on the east.
17	"(vi) 67th Street on the North to 71st
18	Street on the South, from Cottage Grove
19	Avenue/ South Chicago Avenue on the west
20	to the Metra Railroad tracks on the east.
21	"(C) Local coordinating entity.—The
22	Black Metropolis National Heritage Area Com-
23	mission shall be the local coordinating entity for
24	the National Heritage Area designated by sub-
25	paragraph (A).

1	"(9) Downeast maine national heritage
2	AREA.—
3	"(A) In General.—There is established
4	the Downeast Maine National Heritage Area in
5	the State of Maine, consisting of Hancock and
6	Washington Counties, Maine.
7	"(B) Local coordinating entity.—The
8	Sunrise County Economic Council shall be the
9	local coordinating entity for the National Herit-
10	age Area designated by subparagraph (A).
11	"(10) Northern Neck National Heritage
12	AREA, VIRGINIA.—
13	"(A) In General.—There is established
14	the Northern Neck National Heritage Area in
15	the State of Virginia, as depicted on the map
16	entitled 'Northern Neck National Heritage Area
17	Proposed Boundary', numbered 671/177,224,
18	and dated August 2021.
19	"(B) Local coordinating entity.—The
20	Northern Neck Tourism Commission, a working
21	committee of the Northern Neck Planning Dis-
22	trict Commission, shall serve as the local co-
23	ordinating entity for the National Heritage
24	Area designated by subparagraph (A).

1	"(11) St. croix national heritage area,
2	U.S. VIRGIN ISLANDS.—
3	"(A) In general.—There is established
4	on the island of St. Croix, U.S. Virgin Islands,
5	the St. Croix National Heritage Area, con-
6	sisting of the entire island of St. Croix.
7	"(B) Local coordinating entity.—The
8	Virgin Islands State Historic Preservation Of-
9	fice shall be the local coordinating entity for the
10	National Heritage Area designated by subpara-
11	graph (A).
12	"(12) Southern campaign of the revolu-
13	TION NATIONAL HERITAGE CORRIDOR, NORTH CARO-
14	LINA AND SOUTH CAROLINA.—
15	"(A) In general.—There is established
16	the Southern Campaign of the Revolution Na-
17	tional Heritage Corridor in the States of North
18	Carolina and South Carolina, as depicted on the
19	map entitled 'Southern Campaign of the Revo-
20	lution Proposed National Heritage Corridor',
21	numbered 257/177,271, and dated September
22	2021.
23	"(B) Local coordinating entity.—The
24	University of South Carolina shall be the local

1	coordinating entity for the National Heritage
2	Area designated by subparagraph (A).
3	"(13) Southern Maryland National Herit-
4	AGE AREA.—
5	"(A) In General.—There is established
6	the Southern Maryland National Heritage Area
7	in the State of Maryland, as depicted on the
8	map entitled 'Southern Maryland National Her-
9	itage Area Proposed Boundary', numbered 672/
10	177,225B, and dated November 2021.
11	"(B) Local coordinating entity.—The
12	Tri-County Council for Southern Maryland
13	shall be the local coordinating entity for the
14	National Heritage Area designated by subpara-
15	graph (A).".
16	(b) Management Plans.—For the purposes of sec-
17	tion 6001(e) of the John D. Dingell, Jr. Conservation,
18	Management, and Recreation Act (Public Law 116–9; 133
19	Stat. 772), the local coordinating entity for each of the
20	National Heritage Areas designated under the amendment
21	made by subsection (a) shall submit to the Secretary for
22	approval a proposed management plan for the applicable
23	National Heritage Area not later than 3 years after the
24	date of enactment of this Act.

1	(c) TERMINATION OF AUTHORITY.—For the purposes
2	of section 6001(g)(4) of the John D. Dingell, Jr. Con-
3	servation, Management, and Recreation Act (Public Law
4	116-9; 133 Stat. 776), the authority of the Secretary to
5	provide assistance under that section for each of the Na-
6	tional Heritage Areas designated under the amendment
7	made by subsection (a) shall terminate on the date that
8	is 15 years after the date of enactment of this Act.

AN ACT

To standardize the designation of National Heritage Areas, and for other purposes.
