# A BILL

To amend the Coastal Barrier Resources Act to expand the John H. Chafee Coastal Barrier Resources System, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Bolstering Ecosystems*  
 5 *Against Coastal Harm Act” or the “BEACH Act”.*

7       **TITLE I—COASTAL BARRIER**  
 8 **RESOURCES ACT AMENDMENTS**

9 **SEC. 101. DEFINITIONS.**

10       *Section 3 of the Coastal Barrier Resources Act (16*  
 11 *U.S.C. 3502) is amended to read as follows:*

12 **“SEC. 3. DEFINITIONS.**

13       “(a) *IN GENERAL.—For purposes of this Act:*

14       “(1) *COASTAL BARRIER.—The term ‘coastal bar-*  
 15 *rier’ means—*

16               “(A) *a depositional geologic feature (such as*  
 17 *a bay barrier, tombolo, barrier spit, bluff, or bar-*  
 18 *rier island) that—*

1                   “(i) is subject to wave, tidal, and wind  
2                   energies; and

3                   “(ii) protects landward aquatic habi-  
4                   tats from direct wave attack; and

5                   “(B) all associated aquatic habitats includ-  
6                   ing the adjacent wetlands, marshes, estuaries, in-  
7                   lets, and nearshore waters.

8                   “(2) COMMITTEES.—The term ‘Committees’  
9                   means the Committee on Natural Resources of the  
10                  House of Representatives and the Committee on Envi-  
11                  ronment and Public Works of the Senate.

12                  “(3) FINANCIAL ASSISTANCE.—

13                  “(A) IN GENERAL.—The term ‘financial as-  
14                  sistance’ means any form of loan, grant, guar-  
15                  anty, insurance, payment, rebate, subsidy, or  
16                  any other form of direct or indirect Federal as-  
17                  sistance other than—

18                  “(i) deposit or account insurance for  
19                  customers of banks, savings and loan asso-  
20                  ciations, credit unions, or similar institu-  
21                  tions;

22                  “(ii) the purchase of mortgages or  
23                  loans by the Government National Mortgage  
24                  Association, the Federal National Mortgage

1                   *Association, or the Federal Home Loan*  
2                   *Mortgage Corporation;*

3                   “*(iii) assistance for environmental*  
4                   *studies, planning, and assessments that are*  
5                   *required incident to the issuance of permits*  
6                   *or other authorizations under Federal law;*  
7                   *and*

8                   “*(iv) assistance pursuant to programs*  
9                   *entirely unrelated to development, such as*  
10                  *any Federal or federally assisted public as-*  
11                  *sistance program or any Federal old-age*  
12                  *survivors or disability insurance program.*

13                  “*(B) FLOOD INSURANCE.—The term ‘finan-*  
14                  *cial assistance’ includes flood insurance de-*  
15                  *scribed in section 1321 of the National Flood In-*  
16                  *surance Act of 1968, as amended (42 U.S.C.*  
17                  *4028).*

18                  “*(4) GREAT LAKES.—The term ‘Great Lakes’*  
19                  *means Lake Ontario, Lake Erie, Lake Huron, Lake*  
20                  *St. Clair, Lake Michigan, and Lake Superior, to the*  
21                  *extent that those lakes are subject to the jurisdiction*  
22                  *of the United States.*

23                  “*(5) OTHERWISE PROTECTED AREA.—*

24                  “*(A) IN GENERAL.—The term ‘Otherwise*  
25                  *Protected Area’ means any unit of the System*

1           *that, at the time of designation, was predomin-*  
2           *antly composed of areas established under Fed-*  
3           *eral, State, or local law, or held by a qualified*  
4           *organization, primarily for wildlife refuge, wild-*  
5           *life sanctuary, recreational, or natural resource*  
6           *conservation purposes.*

7           “(B) *QUALIFIED ORGANIZATION.*—For pur-

8           *poses of subparagraph (A), the term ‘qualified*  
9           *organization’ has the meaning given the term in*  
10          *section 170(h)(3) of the Internal Revenue Code of*  
11          *1986.*

12          “(6) *SECRETARY.*—The term ‘Secretary’ means

13          *the Secretary of the Interior.*

14          “(7) *SYSTEM.*—The term ‘System’ means the

15          *John H. Chafee Coastal Barrier Resources System es-*  
16          *tablished under section 4(a).*

17          “(8) *SYSTEM UNIT.*—The term ‘System unit’

18          *means any undeveloped coastal barrier, or combina-*  
19          *tion of closely-related undeveloped coastal barriers,*  
20          *included within the John H. Chafee Coastal Barrier*  
21          *Resources System established under section 4(a).*

22          “(9) *UNDEVELOPED COASTAL BARRIER.*—The

23          *term ‘undeveloped coastal barrier’ means a coastal*  
24          *barrier the features and associated habitats of which*  
25          *contain few manmade structures and these structures,*

1       *and man's activities on such features and within such*  
2       *habitats, do not significantly impede geomorphic and*  
3       *ecological processes.*

4       “(b) *SAVINGS CLAUSE.—Nothing in this section super-*  
5       *sedes the official maps described in section 4(a).*”.

6       **SEC. 102. JOHN H. CHAFEE COASTAL BARRIER RESOURCES**

7                   **SYSTEM.**

8       *Section 4 of the Coastal Barrier Resources Act (16*  
9       *U.S.C. 3503) is amended—*

10                “(1) in subsection (a), to read as follows:

11                “(a) *ESTABLISHMENT.—There is established the John*  
12       *H. Chafee Coastal Barrier Resources System, which shall*  
13       *consist of those undeveloped coastal barriers and other areas*  
14       *located on the coasts of the United States that are identified*  
15       *and generally depicted as System units or Otherwise Pro-*  
16       *tected Areas—*

17                “(1) *on the maps on file with the Secretary enti-*  
18       *tled ‘Coastal Barrier Resources System’, dated Octo-*  
19       *ber 24, 1990;*

20                “(2) *on a map described in section 201(b) of the*  
21       *Bolstering Ecosystems Against Coastal Harm Act; or*

22                “(3) *on a map described in paragraph (1) or (2)*  
23       *as such map may be replaced, modified, revised, or*  
24       *corrected under—*

25                “(A) subsection (f)(3);

1               “(B) section 4 of the Coastal Barrier Im-  
2               provement Act of 1990 (16 U.S.C. 3503 note); or

3               “(C) any other provision of law enacted on  
4               or after November 16, 1990, that specifically re-  
5               places or authorizes the modification, revision, or  
6               correction of such a map.”;

7               (2) in subsection (e), by striking “undeveloped”  
8               each place it appears; and

9               (3) in subsection (f)(2), in the matter preceding  
10               subparagraph (A), by striking “copy of the map” and  
11              inserting “notification of the availability of the  
12              map”.

13 **SEC. 103. REQUIRE DISCLOSURE TO PROSPECTIVE BUYERS**

14               **THAT PROPERTY IS IN SYSTEM.**

15               Section 5 of the Coastal Barrier Resources Act (16  
16              U.S.C. 3504) is amended by adding at the end the following:

17               “(c) **DISCLOSURE OF LIMITATIONS.**—Not later than 2  
18              years after the date of the enactment of the Bolstering Eco-  
19              systems Against Coastal Harm Act, the Secretary, in con-  
20              sultation with the Secretary of Housing and Urban Devel-  
21              opment, shall issue regulations requiring the owner or lessor  
22              of real property located in a community affected by this  
23              Act, as determined by the Director of the United States Fish  
24              and Wildlife Service, to disclose to a prospective buyer or  
25              lessee such location of such real property.”.

1   **SEC. 104. EXCEPTIONS TO LIMITATIONS ON EXPENDI-**  
2                         **TURES.**

3           *Section 6 of the Coastal Barrier Resources Act (16  
4 U.S.C. 3505) is amended—*

5           *(1) in subsection (a)(6)(E), to read as follows:*

6           *“(E) Emergency actions necessary to the  
7 saving of lives and the protection of property  
8 and the public health and safety, if such actions  
9 are performed pursuant to sections 402, 403,  
10 407, and 502 of the Robert T. Stafford Disaster  
11 Relief and Emergency Assistance Act (42 U.S.C.  
12 5170a, 5170b, 5173, 5192) and are limited to ac-  
13 tions that are necessary to alleviate the applica-  
14 ble emergency.”; and*

15           *(2) by adding at the end the following:*

16           *“(e) APPLICABILITY TO OTHERWISE PROTECTED  
17 AREAS.—*

18           *“(1) IN GENERAL.—The prohibitions on new  
19 Federal expenditures and financial assistance de-  
20 scribed in section 5(a) do not apply within Otherwise  
21 Protected Areas except with respect to limitations on  
22 new flood insurance coverage described in section  
23 1321 of the National Flood Insurance Act of 1968 (42  
24 U.S.C. 4028).*

25           *“(2) EXCEPTION.—Notwithstanding paragraph  
26 (1), new Federal flood insurance may be provided for*

1       *a structure in an Otherwise Protected Area that is  
2       used in a manner consistent with the purpose for  
3       which such Otherwise Protected Area is protected.*

4       “(f) *APPLICABILITY TO ADDITIONS AND INSURABLE  
5       STRUCTURES.*—

6           “(1) *ADDITIONS.*—With respect to an addition to  
7       the System made under section 4 on or after the date  
8       of the enactment of the Bolstering Ecosystems Against  
9       Coastal Harm Act, subject to paragraph (2), the pro-  
10       hibitions on new Federal expenditures and financial  
11       assistance described in section 5(a) and section 1321  
12       of the National Flood Insurance Act of 1968 (42  
13       U.S.C. 4028) shall take effect on the date that is 1  
14       year after the date on which such addition is made.

15       “(2) *INSURABLE STRUCTURES.*—

16           “(A) *IN GENERAL.*—The prohibitions on  
17       new Federal expenditures and financial assist-  
18       ance described in section 5(a) and section 1321  
19       of the National Flood Insurance Act of 1968 (42  
20       U.S.C. 4028) do not apply to an insurable struc-  
21       ture.

22           “(B) *INSURABLE STRUCTURE DEFINED.*—In  
23       this subsection, the term ‘insurable structure’  
24       means an insurable structure that is—

1                   “(i) located within an addition de-  
2                   scribed in paragraph (1); and  
3                   “(ii) in existence before the expiration  
4                   of the applicable 1-year period described in  
5                   paragraph (1).”.

6   **SEC. 105. IMPROVE FEDERAL AGENCY COMPLIANCE WITH**  
7                   **COASTAL BARRIER RESOURCES ACT.**

8                   Section 7(a) of the Coastal Barrier Resources Act (16  
9                   U.S.C. 3506(a)) is amended to read as follows:

10                  “(a) REGULATIONS.—Not later than 1 year after the  
11                  date of the enactment of the Bolstering Ecosystems Against  
12                  Coastal Harm Act, the head of each Federal agency affected  
13                  by this Act shall revise or issue regulations and guidance  
14                  as necessary to ensure compliance with the provisions of  
15                  this Act.”.

16   **SEC. 106. AUTHORIZATION OF APPROPRIATIONS.**

17                  Section 10 of the Coastal Barrier Resources Act (16  
18                  U.S.C. 3510) is amended by striking “2010” and inserting  
19                  “2031”.
