AN ACT

Making appropriations for the Department of the Interior, environment, and related agencies for the fiscal year ending September 30, 2025, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, for the
- 5 Department of the Interior, environment, and related
- 6 agencies for the fiscal year ending September 30, 2025,
- 7 and for other purposes, namely:

2	DEPARTMENT OF THE INTERIOR
3	Bureau of Land Management
4	MANAGEMENT OF LANDS AND RESOURCES
5	For necessary expenses for protection, use, improve-
6	ment, development, disposal, cadastral surveying, classi-
7	fication, acquisition of easements and other interests in
8	lands, and performance of other functions, including main-
9	tenance of facilities, as authorized by law, in the manage-
10	ment of lands and their resources under the jurisdiction
11	of the Bureau of Land Management, including the general
12	administration of the Bureau, and assessment of mineral
13	potential of public lands pursuant to section 1010(a) of
14	Public Law 96–487 (16 U.S.C. 3150(a)), \$1,185,063,000,
15	to remain available until September 30, 2026; of which
16	\$53,900,000 for annual maintenance and deferred mainte-
17	nance programs and \$143,000,000 (reduced by
18	\$11,000,000) (increased by \$11,000,000) for the wild
19	horse and burro program, as authorized by Public Law
20	92–195 (16 U.S.C. 1331 et seq.), shall remain available
21	until expended: Provided, That amounts in the fee account
22	of the BLM Permit Processing Improvement Fund may
23	be used for any bureau-related expenses associated with
24	the processing of oil and gas applications for permits to
25	drill and related use of authorizations: Provided further.

- 1 That of the amounts made available under this heading,
- 2 up to \$1,000,000 may be made available for the purposes
- 3 described in section 122(e)(1)(A) of division G of Public
- 4 Law 115–31 (43 U.S.C. 1748c(e)(1)(A)): Provided fur-
- 5 ther, That of the amounts made available under this head-
- 6 ing, not to exceed \$15,000 may be for official reception
- 7 and representation expenses.
- 8 In addition, \$42,696,000 is for Mining Law Adminis-
- 9 tration program operations, including the cost of admin-
- 10 istering the mining claim fee program, to remain available
- 11 until expended, to be reduced by amounts collected by the
- 12 Bureau and credited to this appropriation from mining
- 13 claim maintenance fees and location fees that are hereby
- 14 authorized for fiscal year 2025, so as to result in a final
- 15 appropriation estimated at not more than \$1,185,063,000,
- 16 and \$2,000,000, to remain available until expended, from
- 17 communication site rental fees established by the Bureau
- 18 for the cost of administering communication site activities.
- 19 OREGON AND CALIFORNIA GRANT LANDS
- For expenses necessary for management, protection,
- 21 and development of resources and for construction, oper-
- 22 ation, and maintenance of access roads, reforestation, and
- 23 other improvements on the revested Oregon and California
- 24 Railroad grant lands, on other Federal lands in the Or-
- 25 egon and California land-grant counties of Oregon, and

- 1 on adjacent rights-of-way; and acquisition of lands or in-
- 2 terests therein, including existing connecting roads on or
- 3 adjacent to such grant lands; \$107,799,000, to remain
- 4 available until expended: *Provided*, That 25 percent of the
- 5 aggregate of all receipts during the current fiscal year
- 6 from the revested Oregon and California Railroad grant
- 7 lands is hereby made a charge against the Oregon and
- 8 California land-grant fund and shall be transferred to the
- 9 General Fund in the Treasury in accordance with the sec-
- 10 ond paragraph of subsection (b) of title II of the Act of
- 11 August 28, 1937 (43 U.S.C. 2605).
- 12 RANGE IMPROVEMENTS
- For rehabilitation, protection, and acquisition of
- 14 lands and interests therein, and improvement of Federal
- 15 rangelands pursuant to section 401 of the Federal Land
- 16 Policy and Management Act of 1976 (43 U.S.C. 1751),
- 17 notwithstanding any other Act, sums equal to 50 percent
- 18 of all moneys received during the prior fiscal year under
- 19 sections 3 and 15 of the Taylor Grazing Act (43 U.S.C.
- 20 315b, 315m) and the amount designated for range im-
- 21 provements from grazing fees and mineral leasing receipts
- 22 from Bankhead-Jones lands transferred to the Depart-
- 23 ment of the Interior pursuant to law, but not less than
- 24 \$10,000,000, to remain available until expended: Pro-

- 1 vided, That not to exceed \$600,000 shall be available for
- 2 administrative expenses.
- 3 SERVICE CHARGES, DEPOSITS, AND FORFEITURES
- 4 For administrative expenses and other costs related
- 5 to processing application documents and other authoriza-
- 6 tions for use and disposal of public lands and resources,
- 7 for costs of providing copies of official public land docu-
- 8 ments, for monitoring construction, operation, and termi-
- 9 nation of facilities in conjunction with use authorizations,
- 10 and for rehabilitation of damaged property, such amounts
- 11 as may be collected under Public Law 94–579 (43 U.S.C.
- 12 1701 et seq.), and under section 28 of the Mineral Leasing
- 13 Act (30 U.S.C. 185), to remain available until expended:
- 14 Provided, That notwithstanding any provision to the con-
- 15 trary of section 305(a) of Public Law 94–579 (43 U.S.C.
- 16 1735(a)), any moneys that have been or will be received
- 17 pursuant to that section, whether as a result of forfeiture,
- 18 compromise, or settlement, if not appropriate for refund
- 19 pursuant to section 305(c) of that Act (43 U.S.C.
- 20 1735(c)), shall be available and may be expended under
- 21 the authority of this Act by the Secretary of the Interior
- 22 to improve, protect, or rehabilitate any public lands ad-
- 23 ministered through the Bureau of Land Management
- 24 which have been damaged by the action of a resource de-
- 25 veloper, purchaser, permittee, or any unauthorized person,

- 1 without regard to whether all moneys collected from each
- 2 such action are used on the exact lands damaged which
- 3 led to the action: *Provided further*, That any such moneys
- 4 that are in excess of amounts needed to repair damage
- 5 to the exact land for which funds were collected may be
- 6 used to repair other damaged public lands.

7 miscellaneous trust funds

- 8 In addition to amounts authorized to be expended
- 9 under existing laws, there is hereby appropriated such
- 10 amounts as may be contributed under section 307 of Pub-
- 11 lie Law 94–579 (43 U.S.C. 1737), and such amounts as
- 12 may be advanced for administrative costs, surveys, ap-
- 13 praisals, and costs of making conveyances of omitted lands
- 14 under section 211(b) of that Act (43 U.S.C. 1721(b)), to
- 15 remain available until expended.

ADMINISTRATIVE PROVISIONS

- 17 The Bureau of Land Management may carry out the
- 18 operations funded under this Act by direct expenditure,
- 19 contracts, grants, cooperative agreements, and reimburs-
- 20 able agreements with public and private entities, including
- 21 with States. Appropriations for the Bureau shall be avail-
- 22 able for purchase, erection, and dismantlement of tem-
- 23 porary structures, and alteration and maintenance of nec-
- 24 essary buildings and appurtenant facilities to which the
- 25 United States has title; up to \$100,000 for payments, at

- 1 the discretion of the Secretary, for information or evidence
- 2 concerning violations of laws administered by the Bureau;
- 3 miscellaneous and emergency expenses of enforcement ac-
- 4 tivities authorized or approved by the Secretary and to be
- 5 accounted for solely on the Secretary's certificate, not to
- 6 exceed \$10,000: Provided, That notwithstanding Public
- 7 Law 90-620 (44 U.S.C. 501), the Bureau may, under co-
- 8 operative cost-sharing and partnership arrangements au-
- 9 thorized by law, procure printing services from cooperators
- 10 in connection with jointly produced publications for which
- 11 the cooperators share the cost of printing either in cash
- 12 or in services, and the Bureau determines the cooperator
- 13 is capable of meeting accepted quality standards: Provided
- 14 further, That projects to be funded pursuant to a written
- 15 commitment by a State government to provide an identi-
- 16 fied amount of money in support of the project may be
- 17 carried out by the Bureau on a reimbursable basis.
- 18 United States Fish and Wildlife Service
- 19 RESOURCE MANAGEMENT
- 20 For necessary expenses of the United States Fish and
- 21 Wildlife Service, as authorized by law, and for scientific
- 22 and economic studies, general administration, and for the
- 23 performance of other authorized functions related to such
- 24 resources, \$1,385,096,000 (increased by \$1,000,000) (in-
- 25 creased by \$2,000,000) (reduced by \$1,000,000) (in-

- 1 creased by \$1,000,000) (reduced by \$5,268,000), to re-
- 2 main available until September 30, 2026, of which not to
- 3 exceed \$15,000 may be for official reception and represen-
- 4 tation expenses: *Provided*, That not to exceed \$17,597,000
- 5 shall be used for implementing subsections (a), (b), (c),
- 6 and (e) of section 4 of the Endangered Species Act of
- 7 1973 (16 U.S.C. 1533) (except for processing petitions,
- 8 developing and issuing proposed and final regulations, and
- 9 taking any other steps to implement actions described in
- 10 subsection (e)(2)(A), (e)(2)(B)(i), or (e)(2)(B)(ii) of such
- 11 section).
- 12 CONSTRUCTION
- For construction, improvement, acquisition, or re-
- 14 moval of buildings and other facilities required in the con-
- 15 servation, management, investigation, protection, and uti-
- 16 lization of fish and wildlife resources, and the acquisition
- 17 of lands and interests therein; \$8,114,000, to remain
- 18 available until expended.
- 19 COOPERATIVE ENDANGERED SPECIES CONSERVATION
- 20 Fund
- 21 For expenses necessary to carry out section 6 of the
- 22 Endangered Species Act of 1973 (16 U.S.C. 1535),
- 23 \$23,000,000 (reduced by \$1,000,000) (increased by
- 24 \$1,000,000), to remain available until expended, to be de-

- 1 rived from the Cooperative Endangered Species Conserva-
- 2 tion Fund.
- 3 NATIONAL WILDLIFE REFUGE FUND
- 4 For expenses necessary to implement the Act of Octo-
- 5 ber 17, 1978 (16 U.S.C. 715s), \$13,228,000.
- 6 NORTH AMERICAN WETLANDS CONSERVATION FUND
- 7 For expenses necessary to carry out the provisions
- 8 of the North American Wetlands Conservation Act (16
- 9 U.S.C. 4401 et seq.), \$49,000,000, to remain available
- 10 until expended.
- 11 NEOTROPICAL MIGRATORY BIRD CONSERVATION
- 12 For expenses necessary to carry out the Neotropical
- 13 Migratory Bird Conservation Act (16 U.S.C. 6101 et
- 14 seq.), \$5,000,000, to remain available until expended.
- 15 MULTINATIONAL SPECIES CONSERVATION FUND
- 16 For expenses necessary to carry out the African Ele-
- 17 phant Conservation Act (16 U.S.C. 4201 et seq.), the
- 18 Asian Elephant Conservation Act of 1997 (16 U.S.C.
- 19 4261 et seq.), the Rhinoceros and Tiger Conservation Act
- 20 of 1994 (16 U.S.C. 5301 et seq.), the Great Ape Con-
- 21 servation Act of 2000 (16 U.S.C. 6301 et seq.), and the
- 22 Marine Turtle Conservation Act of 2004 (16 U.S.C. 6601
- 23 et seq.), \$21,000,000, to remain available until expended.

1 STATE AND TRIBAL WILDLIFE GRANTS 2 For wildlife conservation grants to States and to the 3 District of Columbia, Puerto Rico, Guam, the United 4 States Virgin Islands, the Northern Mariana Islands, American Samoa, and Indian Tribes under the provisions 6 of the Fish and Wildlife Act of 1956 and the Fish and Wildlife Coordination Act, for the development and imple-8 mentation of programs for the benefit of wildlife and their habitat, including species that are not hunted or fished, 10 \$73,812,000 (increased by \$5,000,000) (reduced by \$2,000,000) (increased by \$2,000,000), to remain avail-12 able until expended: Provided, That of the amount provided herein, \$6,200,000 is for a competitive grant program for Indian Tribes not subject to the remaining provi-14 15 sions of this appropriation: Provided further, \$7,612,000 is for a competitive grant program to imple-16 ment approved plans for States, territories, and other ju-17 18 risdictions and at the discretion of affected States, the re-19 gional Associations of fish and wildlife agencies, not subject to the remaining provisions of this appropriation: Pro-21 vided further, That the Secretary shall, after deducting 22 \$13,812,000 and administrative expenses, apportion the 23 amount provided herein in the following manner: (1) to the District of Columbia and to the Commonwealth of

Puerto Rico, each a sum equal to not more than one-half

of 1 percent thereof; and (2) to Guam, American Samoa, 2 the United States Virgin Islands, and the Commonwealth 3 of the Northern Mariana Islands, each a sum equal to not more than one-fourth of 1 percent thereof: Provided further, That the Secretary of the Interior shall apportion the remaining amount in the following manner: (1) one-third 6 of which is based on the ratio to which the land area of 8 such State bears to the total land area of all such States; 9 and (2) two-thirds of which is based on the ratio to which 10 the population of such State bears to the total population of all such States: Provided further, That the amounts ap-12 portioned under this paragraph shall be adjusted equitably so that no State shall be apportioned a sum which is less than 1 percent of the amount available for apportionment 14 15 under this paragraph for any fiscal year or more than 5 percent of such amount: Provided further, That the Fed-16 17 eral share of planning grants shall not exceed 75 percent 18 of the total costs of such projects and the Federal share 19 of implementation grants shall not exceed 65 percent of 20 the total costs of such projects: Provided further, That the 21 non-Federal share of such projects may not be derived 22 from Federal grant programs: Provided further, That any 23 amount apportioned in 2025 to any State, territory, or other jurisdiction that remains unobligated as of September 30, 2026, shall be reapportioned, together with

- 1 funds appropriated in 2027, in the manner provided here-
- 2 in.
- 3 ADMINISTRATIVE PROVISIONS
- 4 The United States Fish and Wildlife Service may
- 5 carry out the operations of Service programs by direct ex-
- 6 penditure, contracts, grants, cooperative agreements and
- 7 reimbursable agreements with public and private entities.
- 8 Appropriations and funds available to the United States
- 9 Fish and Wildlife Service shall be available for repair of
- 10 damage to public roads within and adjacent to reservation
- 11 areas caused by operations of the Service; options for the
- 12 purchase of land at not to exceed one dollar for each op-
- 13 tion; facilities incident to such public recreational uses on
- 14 conservation areas as are consistent with their primary
- 15 purpose; and the maintenance and improvement of aquar-
- 16 ia, buildings, and other facilities under the jurisdiction of
- 17 the Service and to which the United States has title, and
- 18 which are used pursuant to law in connection with man-
- 19 agement, and investigation of fish and wildlife resources:
- 20 Provided, That notwithstanding 44 U.S.C. 501, the Serv-
- 21 ice may, under cooperative cost sharing and partnership
- 22 arrangements authorized by law, procure printing services
- 23 from cooperators in connection with jointly produced pub-
- 24 lications for which the cooperators share at least one-half
- 25 the cost of printing either in cash or services and the Serv-

- 1 ice determines the cooperator is capable of meeting accept-
- 2 ed quality standards: *Provided further*, That the Service
- 3 may accept donated aircraft as replacements for existing
- 4 aircraft: Provided further, That notwithstanding 31 U.S.C.
- 5 3302, all fees collected for non-toxic shot review and ap-
- 6 proval shall be deposited under the heading "United
- 7 States Fish and Wildlife Service—Resource Management"
- 8 and shall be available to the Secretary, without further
- 9 appropriation, to be used for expenses of processing of
- 10 such non-toxic shot type or coating applications and revis-
- 11 ing regulations as necessary, and shall remain available
- 12 until expended.
- NATIONAL PARK SERVICE
- 14 OPERATION OF THE NATIONAL PARK SYSTEM
- For expenses necessary for the management, oper-
- 16 ation, and maintenance of areas and facilities adminis-
- 17 tered by the National Park Service and for the general
- 18 administration of the National Park Service,
- 19 \$2,709,203,000 (reduced by \$3,000,000) (increased by
- 20 \$3,000,000) (reduced by \$500,000) (increased by
- 21 \$500,000) (increased by \$5,000,000) (reduced by
- 22 \$5,000,000) (increased by \$5,000,000) (increased by
- 23 \$1,000,000) (reduced by \$1,000,000), of which
- 24 \$11,661,000 for planning and interagency coordination in
- 25 support of Everglades restoration and \$15,000,000 for

- 1 uses authorized by section 101122 of title 54, United
- 2 States Code shall remain available until September 30,
- 3 2026, and not to exceed \$15,000 may be for official recep-
- 4 tion and representative expenses: Provided, That funds ap-
- 5 propriated under this heading in this Act are available for
- 6 the purposes of section 5 of Public Law 95–348: Provided
- 7 further, That notwithstanding section 9 of the 400 Years
- 8 of African-American History Commission Act (36 U.S.C.
- 9 note prec. 101; Public Law 115–102), \$3,300,000 of the
- 10 funds provided under this heading shall be made available
- 11 for the purposes specified by that Act: Provided further,
- 12 That sections 7(b) and 8(a) of that Act is amended by
- 13 striking "July 1, 2025" and inserting "July 1, 2026".
- 14 In addition, for purposes described in section 2404
- 15 of Public Law 116–9, an amount equal to the amount de-
- 16 posited in this fiscal year into the National Park Medical
- 17 Services Fund established pursuant to such section of
- 18 such Act, to remain available until expended, shall be de-
- 19 rived from such Fund.
- 20 NATIONAL RECREATION AND PRESERVATION
- 21 For expenses necessary to carry out recreation pro-
- 22 grams, natural programs, cultural programs, heritage
- 23 partnership programs, environmental compliance and re-
- 24 view, international park affairs, and grant administration,
- 25 not otherwise provided for, \$89,593,000 (reduced by

- 1 \$5,000,000) (increased by \$5,000,000) (increased by
- 2 \$2,000,000), to remain available until September 30,
- 3 2026.
- 4 HISTORIC PRESERVATION FUND
- 5 For expenses necessary in carrying out the National
- 6 Historic Preservation Act (division A of subtitle III of title
- 7 54, United States Code), \$168,900,000, to be derived
- 8 from the Historic Preservation Fund and to remain avail-
- 9 able until September 30, 2026, of which \$25,500,000 shall
- 10 be for Save America's Treasures grants for preservation
- 11 of nationally significant sites, structures and artifacts as
- 12 authorized by section 7303 of the Omnibus Public Land
- 13 Management Act of 2009 (54 U.S.C. 3089): *Provided*,
- 14 That an individual Save America's Treasures grant shall
- 15 be matched by non-Federal funds: Provided further, That
- 16 individual projects shall only be eligible for one grant: Pro-
- 17 vided further, That all projects to be funded shall be ap-
- 18 proved by the Secretary of the Interior in consultation
- 19 with the House and Senate Committees on Appropria-
- 20 tions: Provided further, That of the funds provided for the
- 21 Historic Preservation Fund, \$30,250,000 is for the Com-
- 22 petitive Grants Subactivity; \$11,000,000 is for grants to
- 23 Historically Black Colleges and Universities; \$10,000,000
- 24 (reduced by \$15,000,000) (increased by \$15,000,000) is
- 25 for competitive grants for the restoration of historic prop-

- 1 erties of national, State, and local significance listed on
- 2 or eligible for inclusion on the National Register of His-
- 3 toric Places, to be made without imposing the usage or
- 4 direct grant restrictions of section 101(e)(3) (54 U.S.C.
- 5 302904) of the National Historic Preservation Act;
- 6 \$7,000,000 is for a competitive grant program to honor
- 7 the semiquincentennial anniversary of the United States
- 8 by restoring and preserving sites and structures listed on
- 9 the National Register of Historic Places that commemo-
- 10 rate the founding of the nation: Provided further, That
- 11 such competitive grants shall be made without imposing
- 12 the matching requirements in section 302902(b)(3) of title
- 13 54, United States Code to States and Indian Tribes as
- 14 defined in chapter 3003 of such title, Native Hawaiian or-
- 15 ganizations, local governments, including Certified Local
- 16 Governments, and nonprofit organizations.

17 CONSTRUCTION

- 18 For construction, improvements, repair, or replace-
- 19 ment of physical facilities, and related equipment, and
- 20 compliance and planning for programs and areas adminis-
- 21 tered by the National Park Service, \$135,616,000, to re-
- 22 main available until expended: *Provided*, That notwith-
- 23 standing any other provision of law, for any project ini-
- 24 tially funded in fiscal year 2025 with a future phase indi-
- 25 cated in the National Park Service 5–Year Line Item Con-

- 1 struction Plan, a single procurement may be issued which
- 2 includes the full scope of the project: Provided further,
- 3 That the solicitation and contract shall contain the clause
- 4 availability of funds found at 48 CFR 52.232-18: Pro-
- 5 vided further, That National Park Service Donations,
- 6 Park Concessions Franchise Fees, and Recreation Fees
- 7 may be made available for the cost of adjustments and
- 8 changes within the original scope of effort for projects
- 9 funded by the National Park Service Construction appro-
- 10 priation: Provided further, That the Secretary of the Inte-
- 11 rior shall consult with the Committees on Appropriations,
- 12 in accordance with current reprogramming thresholds,
- 13 prior to making any charges authorized under this head-
- 14 ing.

15 CENTENNIAL CHALLENGE

- 16 For expenses necessary to carry out the provisions
- 17 of section 101701 of title 54, United States Code, relating
- 18 to challenge cost share agreements, \$12,000,000, to re-
- 19 main available until expended, for Centennial Challenge
- 20 projects and programs: Provided, That not less than 50
- 21 percent of the total cost of each project or program shall
- 22 be derived from non-Federal sources in the form of do-
- 23 nated cash, assets, or a pledge of donation guaranteed by
- 24 an irrevocable letter of credit.

1	ADMINISTRATIVE PROVISIONS
2	(INCLUDING TRANSFER OF FUNDS)
3	In addition to other uses set forth in section
4	101917(c)(2) of title 54, United States Code, franchise
5	fees credited to a sub-account shall be available for ex-
6	penditure by the Secretary, without further appropriation
7	for use at any unit within the National Park System to
8	extinguish or reduce liability for Possessory Interest or
9	leasehold surrender interest. Such funds may only be used
10	for this purpose to the extent that the benefitting unit an-
11	ticipated franchise fee receipts over the term of the con-
12	tract at that unit exceed the amount of funds used to ex-
13	tinguish or reduce liability. Franchise fees at the benefit-
14	ting unit shall be credited to the sub-account of the origi-
15	nating unit over a period not to exceed the term of a single
16	contract at the benefitting unit, in the amount of funds
17	so expended to extinguish or reduce liability.
18	For the costs of administration of the Land and
19	Water Conservation Fund grants authorized by section
20	105(a)(2)(B) of the Gulf of Mexico Energy Security Act
21	of 2006 (Public Law 109–432), the National Park Service
22	may retain up to 3 percent of the amounts which are au-
23	thorized to be disbursed under such section, such retained
24	amounts to remain available until expended.

- 1 National Park Service funds may be transferred to
- 2 the Federal Highway Administration (FHWA), Depart-
- 3 ment of Transportation, for purposes authorized under 23
- 4 U.S.C. 203. Transfers may include a reasonable amount
- 5 for FHWA administrative support costs.
- 6 United States Geological Survey
- 7 SURVEYS, INVESTIGATIONS, AND RESEARCH
- 8 For expenses necessary for the United States Geo-
- 9 logical Survey to perform surveys, investigations, and re-
- 10 search covering topography, geology, hydrology, biology,
- 11 and the mineral and water resources of the United States,
- 12 its territories and possessions, and other areas as author-
- 13 ized by 43 U.S.C. 31, 1332, and 1340; classify lands as
- 14 to their mineral and water resources; give engineering su-
- 15 pervision to power permittees and Federal Energy Regu-
- 16 latory Commission licensees; administer the minerals ex-
- 17 ploration program (30 U.S.C. 641); conduct inquiries into
- 18 the economic conditions affecting mining and materials
- 19 processing industries (30 U.S.C. 3, 21a, and 1603; 50
- 20 U.S.C. 98g(a)(1)) and related purposes as authorized by
- 21 law; and to publish and disseminate data relative to the
- 22 foregoing activities; \$1,374,385,000 (reduced by
- 23 \$1,000,000) (increased by \$1,000,000) (increased by
