## A BILL

To amend the Homeland Security Act of 2002 to require law enforcement officers and agents of the Department of Homeland Security engaged in border security or immigration enforcement to display or wear certain insignia and provide identification, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “No Secret Police Act  
5 of 2025”.

6 **SEC. 2. INSIGNIA AND IDENTIFICATION REQUIRED FOR**  
7                   **LAW ENFORCEMENT OFFICERS AND AGENTS**  
8                   **ENGAGED IN BORDER SECURITY OR IMMI-**  
9                   **GRATION ENFORCEMENT.**

10       (a) IN GENERAL.—Title VII of the Homeland Secu-  
11 rity Act of 2002 (6 U.S.C. 341 et seq.) is amended by  
12 adding at the end the following new section:

13 **“SEC. 714. INSIGNIA AND IDENTIFICATION REQUIRED FOR**  
14                   **LAW ENFORCEMENT OFFICERS AND AGENTS**  
15                   **ENGAGED IN BORDER SECURITY OR IMMI-**  
16                   **GRATION ENFORCEMENT.**

17       “(a) REQUIREMENTS.—

18               “(1) IN GENERAL.—If a law enforcement offi-  
19 cer or agent of the Department detains or arrests an  
20 individual in connection with a border security or  
21 immigration enforcement function of such officer or  
22 agent, during such detention or arrest, as the case  
23 may be, such officer or agent—

24               “(A) shall—

1           “(i) provide such individual with an  
2           identification of the component of the De-  
3           partment that employs such officer or  
4           agent; and

5           “(ii) display or wear the official insig-  
6           nia or uniform of such officer or agent in  
7           a manner that is visible to individuals  
8           other than such officer or agent; and

9           “(B) may not wear a face covering or any  
10          other item that conceals the face of such officer  
11          or agent.

12          “(2) RULE OF CONSTRUCTION.—Nothing in  
13          this subsection may be construed to limit or prohibit  
14          the use of tactical gear by law enforcement officers  
15          and agents consistent with the policies and proce-  
16          dures of the Department.

17          “(3) REPORTS.—

18                 “(A) INITIAL REPORT.—Not later than 30  
19                 days after the date of the enactment of this sec-  
20                 tion, the Secretary shall submit to the Com-  
21                 mittee on Homeland Security of the House of  
22                 Representatives and the Committee on Home-  
23                 land Security and Governmental Affairs of the  
24                 Senate a report on the policies and procedures  
25                 of the Department regarding the use of tactical

1 gear by law enforcement officers and agents of  
2 the Department.

3 “(B) UPDATES.—If the Secretary modifies  
4 the policies or procedures of the Department re-  
5 garding the use of tactical gear by law enforce-  
6 ment officers or agents of the Department, not  
7 later than 30 days after any such modification,  
8 the Secretary shall submit to the Committee on  
9 Homeland Security of the House of Representa-  
10 tives and the Committee on Homeland Security  
11 and Governmental Affairs of the Senate a re-  
12 port relating thereto.

13 “(b) RESEARCH AND DEVELOPMENT.—The Sec-  
14 retary, acting through the Under Secretary for Science  
15 and Technology, and in coordination with the heads of  
16 components of the Department that employ law enforce-  
17 ment officers or agents, shall carry out research and devel-  
18 opment of technology to maximize the visibility of the offi-  
19 cial insignia or uniform of such an officer or agent to be  
20 utilized during detentions or arrests, including technology  
21 to maximize such visibility in response to certain factors  
22 in connection with such detentions or arrests, including  
23 the following:

24 “(1) Location.

25 “(2) Time of day.

1           “(3) Weather.

2           “(c) DEFINITIONS.—In this section:

3           “(1) LAW ENFORCEMENT OFFICER OR  
4 AGENT.—The term ‘law enforcement officer or  
5 agent’ means a law enforcement officer or agent of  
6 the Department, including U.S. Immigration and  
7 Customs Enforcement.

8           “(2) OFFICIAL INSIGNIA OR UNIFORM.—The  
9 term ‘official insignia or uniform’ has the meaning  
10 given such term in section 716 of title 18, United  
11 States Code.”.

12          (b) CLERICAL AMENDMENT.—The table of contents  
13 in section 1(b) of the Homeland Security Act of 2002 is  
14 amended by inserting after the item relating to section  
15 713 the following new item:

“Sec. 714. Insignia and identification required for law enforcement officers and  
agents engaged in border security or immigration enforce-  
ment.”.
