A BILL

To amend title 10, United States Code, to modify the definitions relating to humanitarian demining assistance and stockpiled conventional munitions assistance.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as “the Defining Humanitarian
5 Demining Assistance Act of 2025”.

1 **SEC. 2. DEFINITIONS RELATING TO HUMANITARIAN**
2 **DEMINING ASSISTANCE AND STOCKPILED**
3 **CONVENTIONAL MUNITIONS ASSISTANCE.**

4 Subsection (e) of section 407 of title 10, United
5 States Code, is amended to read as follows:

6 “(e) In this section:

7 “(1) The term ‘humanitarian demining assist-
8 ance’, as it relates to training and support—

9 “(A) means detection and clearance of
10 landmines, unexploded explosive ordnance, and
11 other explosive remnants of war; and

12 “(B) includes activities related to the use
13 of competencies prescribed by the International
14 Mine Action Standards to furnish education,
15 training, technical assistance, and infrastruc-
16 ture development with respect to, and equip-
17 ment for—

18 “(i) the detection and clearance of
19 landmines, unexploded explosive ordnance,
20 and other explosive remnants of war.

21 “(ii) the development of national
22 standards and standard operating proce-
23 dures for such detection and clearance; and

24 “(iii) explosive safety.

1 “(2) The term ‘stockpiled conventional muni-
2 tions assistance’, as it relates to the support of hu-
3 manitarian assistance efforts—

4 “(A) means training and support in the
5 disposal, demilitarization, physical security of
6 stockpiles, and lifecycle stockpile management
7 of potentially dangerous stockpiles of explosive
8 ordnance, small arms, and light weapons, in-
9 cluding man-portable air-defense systems; and

10 “(B) includes activities related to the use
11 of International Ammunition Technical Guide-
12 lines to support the capacity building of a for-
13 eign security institution by furnishing edu-
14 cation, training, technical assistance, and infra-
15 structure development with respect to, and
16 equipment for—

17 “(i) explosive safety, and

18 “(ii) the disposal, demilitarization,
19 physical security of stockpiles, stockpile
20 management, national standards and
21 standard operating procedure development
22 of potentially dangerous stockpiles of ex-
23 plosive ordnance, small arms, and light

1 weapons, including man-portable air-de-
2 fense systems.”.
