Mr. MORAN introduced the following bill; which was read twice and referred to the Committee on Armed Services

A BILL

To amend title 10, United States Code, to expand authorities for intergovernmental support agreements for the Department of Defense, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Expanding Defense
5 Community Partnerships Act”.

1 **SEC. 2. EXPANSION OF AUTHORITY OF DEPARTMENT OF**
2 **DEFENSE FOR INTERGOVERNMENTAL SUP-**
3 **PORT AGREEMENTS.**

4 (a) IN GENERAL.—Section 2679 of title 10, United
5 States Code, is amended—

6 (1) in subsection (a)—

7 (A) in paragraph (4), by striking “provided
8 in subsection (a)” and inserting “under para-
9 graph (1)”; and

10 (B) by adding at the end the following new
11 paragraph:

12 “(5) In entering into or carrying out an intergovern-
13 mental support agreement under paragraph (1), the Sec-
14 retary concerned or the State, local, or tribal government,
15 as the case may be, may agree to partner or collaborate
16 with another Federal agency or agencies to provide, re-
17 ceive, or share installation-support services.”;

18 (2) in subsection (c), by striking the first sen-
19 tence and inserting the following: “To pay the costs
20 of installation-support services under an intergovern-
21 mental support agreement under this section, the
22 Secretary concerned may use funds available to the
23 Secretary concerned for operation and maintenance,
24 research, development, test, and evaluation, procure-
25 ment of ammunition, or military construction and

1 may use non-appropriated funds available to the
2 Secretary concerned.”;

3 (3) in subsection (e)(4), by striking “September
4 30, 2025” and inserting “September 30, 2030”; and

5 (4) in subsection (f)(1), by inserting “, includ-
6 ing those for repair, construction, maintenance, or
7 operation of a facility,” after “for its own needs”.

8 (b) PILOT PROGRAM.—The Secretary of Defense
9 shall carry out a pilot program under which the Secretary
10 may enter into not more than one intergovernmental sup-
11 port agreement under section 2679 of title 10, United
12 States Code, for each of the Army, the Navy, and the Air
13 Force for a term not to exceed 20 years, notwithstanding
14 the limitation under subsection (a)(2)(A) of such section.
