Making further continuing appropriations for the fiscal year ending September 30, 2025, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Further Additional
5 Continuing Appropriations and Other Extensions Act,
6 2025”.

3 SEC. 101. The Continuing Appropriations Act, 2025
4 (division A of Public Law 118–83) is further amended—

5 (1) by striking the date specified in section
6 106(3) and inserting “April 11, 2025”;

1 “SEC. 172. In addition to amounts otherwise pro-
2 vided by section 101, for ‘Federal Emergency Manage-
3 ment Agency—Disaster Relief Fund’, there is appro-
4 priated \$750,000,000, for an additional amount for fiscal
5 year 2025, to remain available until expended, for major
6 disasters declared pursuant to the Robert T. Stafford Dis-
7 aster Relief and Emergency Assistance Act (42 U.S.C.
8 5121 et seq.): *Provided*, That such amount is designated
9 by the Congress as being for an emergency requirement
10 pursuant to section 251(b)(2)(A)(i) of the Balanced Budg-
11 et and Emergency Deficit Control Act of 1985, and shall
12 be available only if the President subsequently so des-
13 ignates such amount and transmits such designation to
14 the Congress.
