

***In the Senate of the United States,***

*January 30, 2026.*

*Resolved,* That the bill from the House of Representatives (H.R. 7148) entitled “An Act making further consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes.”, do pass with the following

**AMENDMENTS:**

1 **(1)**In section 2 in the matter preceding division A, strike  
2 the matter relating to division H and insert:

3 *Division H—Further Continuing Appropriations Act,*  
4 *2026*

5 **(2)**On page 4, strike lines 17 through 25.

6 **(3)**Beginning on page 1132, strike line 9 and all that fol-  
7 lows through “Sec. 554.” on page 1235, line 16, and in-  
8 sert:

1     ***DIVISION H—FURTHER CONTINUING***  
2     ***APPROPRIATIONS ACT, 2026***

3     *SEC. 101. The Continuing Appropriations Act, 2026*  
4     *(division A of Public Law 119–37) is amended by striking*  
5     *the date specified in section 106(3) and inserting “February*  
6     *13, 2026”.*

7     *SEC. 102. For the purposes of the Continuing Appro-*  
8     *priations Act, 2026 (division A of Public Law 119–37), the*  
9     *time covered by such division shall be considered to include*  
10    *the period which began on or about January 31, 2026, dur-*  
11    *ing which there occurred a lapse in appropriations.*

12    *SEC. 103. Amounts made available in the Continuing*  
13    *Appropriations Act, 2026 (division A of Public Law 119–*  
14    *37) and the Consolidated Appropriations Act, 2026 for per-*  
15    *sonnel pay, allowances, and benefits in each department*  
16    *and agency shall be available for payments pursuant to sub-*  
17    *section (c) of section 1341 of title 31, United States Code*  
18    *and such payments shall be made.*

19    *SEC. 104. All obligations incurred and in anticipation*  
20    *of the appropriations made and authority granted by the*  
21    *Continuing Appropriations Act, 2026 (division A of Public*  
22    *Law 119–37) and by the Consolidated Appropriations Act,*  
23    *2026 for the purposes of maintaining the essential level of*  
24    *activity to protect life and property and bringing about or-*  
25    *derly termination of Government function, and for purposes*

1 *as otherwise authorized by law, are hereby ratified and ap-*  
2 *proved if otherwise in accord with the provisions of such*  
3 *Act.*

4 *SEC. 105.*

5 **(4)**On page 1235, strike lines 22 and 23 and insert: *This*  
6 *division may be cited as the “Further Continuing Appro-*  
7 *priations Act, 2026”.*
