6.4 Pa House and Election Bill - Proposed Constitutional Amendment to Require Voter ID Earns Committee Approval -

In addition to action on the reintroduced Voting Rights Protection Act, the House State Government Committee gave its approval to a bill proposing several election-related amendments to the state Constitution, including one that would require voters to present an ID each time they cast a ballot.

Surveys have shown a large majority of Pennsylvanians support enhanced voter ID requirements to protect the security and sanctity of the state’s elections. Despite arguments made by voter ID opponents, recent studies also have shown voter identification laws don’t cause voter turnout, including that of minorities, to decrease. In addition to requiring ID to be presented at the polls each time a person votes, the proposed amendment also would require county election administrators to confirm an applicant’s eligibility to vote prior to approving their registration application.

[House Bill 1596](#) is also proposing additional separate and distinct constitutional amendments to better align the state Constitution with the U.S. Constitution; prohibit private financing of elections administration and require additional ballot security; strengthen uniformity requirements for election administration; require robust election audits conducted by the auditor general; and establish the Secretary of the Commonwealth as an elected position, rather than one that is appointed by the governor and confirmed by the Senate.

The measure goes to the full House for consideration. In order to amend the Constitution, a measure must pass both the House and Senate in identical form in two consecutive sessions of the General Assembly and then earn approval from the majority of voters on a ballot referendum.

7. Current Issues & Activist Efforts:

7.1 Grandview School and the Goslin Decision – A cafeteria worker for the Pittsburgh Public Schools was arrested after a firearm was found in her desk. A spokesperson for the school stated that while the individual has a LTCF, firearms regardless of license status are not permitted on school grounds.

7.1.1 The Gun Free Schools Zones Act 1990/1995 – This was originally passed as a feel-good gesture by politicians in response to the alleged “national epidemic of gun violence plaguing our education system.” The act states it shall be unlawful to knowingly possess a firearm within a school zone – defined as within 1000ft of a school or on school property. The 1990 law was struck down by SCOTUS stating that this Act was an unconstitutional exercise of Congressional authority under the Commerce Act (US vs Lopez 1995). Following this decision then AG Reno proposed a change adding that the firearm in question “has moved in or otherwise affects interstate commerce.” This was added and the amended act was repassed as the GFSZ Act of 1995. Following this the prosecutor would need to establish this first to proceed with the case. As nearly all firearms have at some point moved in interstate commerce this was an attempt to circumvent the SCOTUS ruling. https://en.wikipedia.org/wiki/Gun-Free_School_Zones_Act_of_1990 At this point it has yet to be challenged in SCOTUS.

Seven exceptions are allowed. <https://www.concealedcarry.com/law/defining-gun-free-school-zones-act/> One of the exceptions is that the individual possessing the firearm is licensed to carry by the State in which the school zone is located. Pa however has never in the past recognized this exception due to the unwillingness of judges and prosecutors to reaffirm legislative intent properly! Title 18, Section 912 (c) of Pa law provides a defendant with a defense of possessing a weapon on school property if it is in connection with a school activity or for “other lawful purpose.” Prosecutors and courts however had historically interpreted the latter “lawful purpose” as being linked to the former, a school activity. <https://foac-pac.org/uploads/Laws-Legislation/LAWS-RelatingToGuns-PA-18-02-Compr.pdf> pg 72

7.1.2 The Goslin Decision 2017 – Mr Goslin was a carpenter who went to the school to discuss his son’s 3-day suspension for bringing a knife to school. In the midst of the discussion Mr Goslin was found to also possess a knife – a tool of his carpentry trade. He was subsequently charged with possession of a weapon on school property, was tried and convicted. Josh Prince took on the appeal of this case and argued to the Pa Superior Court. The Court En Banc agreed with him and vacated MrGoslin’s conviction decision and ordered a new trial. The Decision stated that the language of section 912 (c) is clear and ambiguous and that they describe two separate defenses – related to school activity or for other lawful purpose. https://princelaw.files.wordpress.com/2017/02/vacated_remanded.pdf Upon the decision and the overturn of the conviction the DA chose not to pursue and additional legal action against Mr Goslin. <https://blog.princelaw.com/2017/02/16/the-goslin-decisions-impact-on-possessing-weapons-on-school-property/> and <https://blog.princelaw.com/2017/02/16/chief-counsel-prince-secures-monumental-decision-from-the-superior-court-en-banc-regarding-possession-of-weapons-on-school-property/>

While this was a monumental decision, what did it mean for firearm owners? It does not prevent an individual from being arrested or charged. What it does is provide a legally recognized defense to the charges. Additionally, the Goslin case involved a knife and while the same reasoning should apply to lawful possession of a firearm it has not yet been tested in the courts. The Grandview cafeteria worker can be a test case. It is critical that she choose the best attorney and that her case been handled most appropriately. The best choice clearly would be Attorney Prince. The outcome of this case while having important consequences for the defendant will also have important consequences to all Pa firearm owners. An update – checking with Attorney Prince his firm has not yet been approached on this case.

7.1.3 The Tragic Failure of GFSZ –Following the passage of the Gun Free School Zones Act mass murders within education settings proliferated. While the GFSZ applies to elementary or secondary education settings, colleges have also voluntarily set themselves up at Gun Free Zones prohibiting their students and personnel from having the effective means to protect themselves from assault, injury or death. Both commonsense as well as research shows that mass murders choose gun free zones to operate in. While firearms as protective tools are used to guard politicians, celebrities, money, jewelry, art, etc gun grabbers refuse to consider the use of responsibly armed individuals as a deterrent to these tragedies in schools. They essentially encourage people to be victims rather than defend themselves. Schools with armed personnel

programs have not seen mass murders. Since up to 97% of mass murders are perpetrated in a Gun Free Zone, it is only real commonsense to not create one.

7.2 The Ruling Elite is Anti-American –“The last several years have exposed a ruling class that is openly hostile to the rights of American citizens. 7.3 Chicago’s answer to spiraling homicides – Amidst the 2688 shootings and 602 homicides so far – all increased from last year – the City has responded to the skyrocketing crime rate by putting up 426 Bleeding Control Kits around the city. This is part of the “Safe Chicago “ program – obviously an oxymoron! https://www.chicago.gov/city/en/depts/oem/supp_info/safe-chicago.html Each kit contains a tourniquet, gauze, shears, gloves, and an instruction manual on how to best use it in instances of life threatening bleeding emergencies. While trauma kits are a good thing, as firearm owners that should be one of our staples, responding to an immediate bleeding emergency involves appropriate training, as does the equipment included in these kits. How many of those involved in precipitating or witnessing the bleeding events have training or are going to be inclined to use them. This is another clear demonstration that Chicago has lost control of the criminal element and continues to refuse realistic approaches that actually reduce crime. Disarming law abiding residents and failing to prosecute criminals’ works just great!!!Right!

7.3.1 Chicago Prosecutor refuses to prosecute gang members involved in a gun battle, terming them “mutual combatants.” Even Mayor Lightfoot is angry about this one.

7.4 Smith & Wesson Leaves Massachusetts – Amidst anti-gun threat Smith & Wesson management decides it must leave Massachusetts where it has been located for 170 years. The bills postured as a “act to stop mass shootings” which are likely to be passed by the anti-gun Massachusetts legislature, would ban the manufacture of the firearms that made up more than 60 percent of the company’s gross revenue last year. They would preclude the company, and many of the 24 other gun makers presently located in the state, from manufacturing so-called assault weapons and high-capacity magazines. The state already forbids its citizens to purchase, sell, or possess such items. The bills would be an extension of the state’s anti-gun mentality, applying it to gun makers as well. While many gun friendly locales approached S&W, the decision was to relocate to Maryville, Tennessee. These laws passed by gun grabbing politicians have no effect on decreasing mass murders, or any type of crime. Instead this kind of thinking actually does the opposite and increases crime, making mass murders more likely. 7.5 135 Republicans Voted To Confiscate Guns From Our Veterans In Latest NDAA Bill – see: <https://gunsinthenews.com/the-135-republicans-who-voted-to-confiscate-guns-from-our-veterans-in-latest-ndaa-bill/> for names. In Pa all R members of Congress voted for this bill with the exception of two Scott Perry (FOAC A+ <https://foac-pac.org/Federal-Legislator-Details/8>) and Lloyd Smucker (FOAC B+ <https://foac-pac.org/Federal-Legislator-Details/29>) The 1,300 page 2022 National Defense Authorization Act contained a Red Flag provision. “The military version of the red flag law proposed by Democrats looks a lot like the civilian version found in more than a dozen states. Without being charged or even accused of a crime, a service member could have their right to possess a firearm taken away from them by a military court, and the subject of the red flag order wouldn’t even have a chance to provide any evidence on their behalf for up to 30 days after the court’s order was issued. The authors of the measure audaciously state that this is “sufficient to protect the respondent’s due process rights,” but I doubt many service members would agree. As well as the obvious concerns over the constitutionality of this proposal, there are fundamental flaws with the measure itself. Just like with the red flag laws in place in states from California to Connecticut, if a person *is* found (through a lowered standard of review than what is used in a criminal proceeding) to be a danger to themselves or others by a judge, there’s no actual mental health component to the order removing guns. A supposedly dangerous person can be left with knives, pills, poison, gasoline and matches, and any other tool they might use to take their own life or the lives of others as long as any legally-owned guns are taken away. Every state (and the military as well) already have civil commitment laws on the books, and they’re the most appropriate tool to deal with individuals who are truly in the midst of a mental health crisis.” <https://foac-pac.org/Dems-Slip-Red-Flag-Provision-Into-Military-Spending-Bill/News-Item/12821> While some R Congressionals are attempting to back track on their vote, the question critical question is why did they vote for it to begin with. Was this a Nancy Pelosi moment: “We must pass it to know what’s in it?” Call your Federal Rep and ask them why??

I traveled to Harrisburg on September 27 and September 28 to shore up support for the Senate bill SB 565, Constitutional carry, as well as to deal with the controversies surrounding three Senate resolutions, SR 152-SR 67 and SR 127 (resolutions calling for an Article V of the Federal Constitution).

In making the rounds from various Sen. offices it became clear that constitutional carry enjoys widespread support and will very likely be coming up when the Senate reconvenes in October. The issue of a Constitutional Convention based on calls for an Article V remain problematic with three various pieces of legislation that, while only resolutions, fulfill the requirements of the United States Constitution to essentially open a Pandora's box of changes that will be most likely uncontrollable.

On Tuesday, September 28, a meet and greet sponsored by Representative Matthew Dowling was held in the Irvis office building at 8:30 AM. The purpose of this meet and greet was to familiarize legislators with FOAC and our positions on issues. There were between 40 and 50 members of the Pennsylvania House of Representatives who attended this meet and greet and it was a wonderful opportunity to get a chance to share our positions on issues and to build an even closer bond of trust and respect with members of the legislature.

The final event for Tuesday, September 28, was the Pennsylvania Senate hearing at noon by the State Government committee that dealt with the three resolutions mentioned above regarding calls for an Article V Constitutional Convention. Two of the resolutions were non-starters, SR 67 and SR 127 did not even come up. SR 152 was brought up by the sponsor, Sen. Cris Dush, but the commentary from the senator seem to indicate his motivations behind pushing for this measure rather than its viability. Once he was done with his presentation (about five minutes) he asked the committee chair, Sen. David Argall, to table SR 152 for further clarification of the legislative intent.

In the end, this was a very positive and worthwhile trip to Harrisburg, not the least of which was to be able to see how the pro-life crowd holds a rally. Gun owners could learn a lot from their dedication and perseverance on this issue of pro-life, antiabortion stance.
